Pursuant to Arizona Revised Statute (A.R.S.) § 38-431.02(F), notice is hereby given to the Trustees of the Arizona State Retirement System (ASRS) Board Appeals Committee (AC) and to the general public that the ASRS Board AC will hold a meeting open to the public on Tuesday, June 11, 2019, beginning at 9:30 a.m., in the 10th Floor Board Room of the ASRS offices at 3300 N. Central Avenue, Phoenix, Arizona 85012. Trustees of the Committee may attend either in person or by telephone conference call.

As a result of public comment, the Board AC may direct staff to study and/or reschedule the matter for discussion and decision at a later date.
