- b) **Approval of Memorandum of Understanding with the Great Basin Bird Observatory. Presenter: Josh T. Avey, Branch Chief, Terrestrial Wildlife Branch.** The Commission may approve a Memorandum of Understanding with the Great Basin Bird Observatory for the purpose of conservation and management of wildlife and related educational programs, primarily to benefit bird SGCN through research and monitoring projects.
- 3) **Requests from Regions I, II, III, IV, and V for short road closures on State Trust Land. Presenter: Dan Sturla, Landowner Relations Program Supervisor.** As part of continued implementation of the joint protocol for management of motor vehicle access on State Trust lands (STL) between the Arizona Game and Fish Department (AGFD) and Arizona State Land Department (ASLD), the Department and ASLD have resolved 99 unauthorized road closures on STL resulting in restored public access to over 240,000 acres in the past 3 years. Last year’s efforts alone opened 30 gates on STL. The Commission will be provided an update on Department efforts and success, and may approve 7 new petitions requesting to close 12 short roads on State Trust lands, plus 6 requests to renew existing closures. The Commission may vote to take action on, or provide the Department direction on this item.
- 4) **Update on the Department’s evaluation of alternatives for the issuance, sale, and transfer of Special Big Game License Tags. Presenter: Clay Crowder, Assistant Director, Wildlife Management Division.** The Commission will be updated on the Department’s initial evaluation of alternatives regarding the issuance, sale and transfer of Special Big Game License Tags.


