I. Call to Order and Roll Call

Commissioner David Sanders called the meeting to order at 1:31 pm. **Ms. Boyle** took roll call, and a quorum was declared.

II. Minutes of the January 13, 2023 meeting

Commissioner Sanders called for a motion on the Committee meeting minutes for January 13, 2023. **Commissioner Steve Stahl** entered a motion to approve the minutes. The motion seconded by **Commissioner Jean Bishop** was unanimously approved by the Committee.

III. Review Introduced Criminal Justice Legislation

Molly Edwards reviewed the concerns of **HB 2195** –Criminal Justice data collection bill on the language. ACJC will continue to work on the wording to ensure there will not be releasing or publishing any personally identifiable information and will only show aggregated information on the dashboards.

On the tracking bills that directly impact ACJC, **HB 2331** –is a membership bill that increases the number on the board to add an indigent defense attorney, private non-profit juvenile justice organization, psychologist, or psychiatrist. After review, **Commissioner Stahl** moved to oppose the language as in the bill; **Commissioner Bishop** seconded the motion, and the Committee unanimously approved.

HB 2333 is an appropriation coordinate and re-entry planning bill that appropriates \$17M from the general fund for FY2023 and 2024 to ADOA. It distributes to counties for the coordinated re-entry planning services program. \$3M would go to ACJC to develop a cross-system recidivism tracking database. Staff recommended remaining neutral and continuing to monitor the bill, and the Committee agreed.

HB 2418 – requires municipalities to provide for law enforcement patrol officers to achieve a response time to each law enforcement emergency call of five minutes or less and require ACJC to establish policies and procedures that define law enforcement emergency response times. Staff recommends monitoring the bill for now, and the Committee agreed.

HB 2500 – this bill adopts rules for the allocation of monies from the victim compensation and assistance fund that includes a woman who is a victim of a sexual offense and carries a resulting baby to term. The victim would receive payment for health care expenses and economic support during the pregnancy and up to 12 months after the baby is born. Appropriation of \$5M would come from the general fund for FY2023 and 2024 to fund ACJC. Staff recommended remaining neutral and continuing to monitor the bill, and the Committee agreed.

SB 1050 – DUI and data collection bill. Appropriates \$250,000 from the general fund for FY2023 and 2024 to ACJC to enter a contract or a report that examines the various data collection processes relating to driving under the influence made by law enforcement agencies, crime labs, prosecutorial agencies, and courts in Arizona. The consensus is to continue to monitor this bill.

SB 1058 – removes the requirement for polygraph tests for incoming law enforcement officers and volunteer officers. The Committee reviewed and agreed the requirement should stay, but ACJC would wait to take a position.
