### 1. Call to Order and Roll Call

At 1:33 p.m., the meeting was called to order by **Chairman David Byers**, **Ana Maris** conducted the roll call, and a quorum was established.

### 2. Minutes of the January 26, 2024 meeting

During the Committee meeting, **Chairman Byers** requested a motion to approve the minutes. The motion was put forward by **Commissioner Jean Bishop** and was unanimously approved by the Committee, with **Designee Daven Byrd** seconding the motion.

### 3. Update and Review of ACJC priority legislation

#### A. Update and Review of ACJC SCMODS priority legislation

During the meeting, **Molly Edwards** updated the Committee on where ACJC's data collection bills are in the legislative process. Edwards stated that an amendment is being added to SB1117, concerns about funding are addressed, and the bill is to be heard in Senate MAPS on February 14, 2024. ACJC's membership bill has been assigned to the House Government Committee. The bill sponsor is working on getting bi-partisan support. ACJC has signed in support of HB2243 and **Molly Edwards** asks others on the Committee to do the same.

### 4. Review Introduced Criminal Justice Legislation

**Molly Edwards** stated that the following bills might be of interest to the Committee: HB2043, HB2134, and its mirror bill SB1408, and gives updates on each of the bills' Legislative processes. ACJC and many others are not in support of HB2043, and it may be revived in future terms. ACJC and the Pinal County Attorney

are in support of HB2134 and SB1408. **Chairman Byers** mentioned HB2045. **Designee Rebecca Baker** stated that her office is in support of SB1474, and recommends the Committee monitors SB1646.

**5. Call to the Public**

There were no emails or calls from the public.

**6. Date, Time, and Location of Next Meeting**

The Joint Executive Legislative Committee meeting is scheduled to take place at the discretion of the chair.
