I. Call to Order and Roll Call

The meeting was called to order by Chief David Sanders at 1:32 pm. Roll was taken and a quorum was declared present.

II. Minutes of the February 9, 2018 Meeting

Chief Sanders called for a motion on the minutes. Joe Brugman entered a motion to approve the minutes of the meeting held on February 9, 2018. The motion was seconded by Mark Napier and was unanimously approved by the Committee.

III. ACJC Legislative Priorities

Jaime Watson, Public Information Officer/Legislative Liaison discussed ACJC's legislative priorities regarding Protective Orders, HB 2249 and Criminal Justice Commission; Reporting Requirements, HB 2247.

HB 2249 passed the House of Representatives with a vote of 57-0 on February 15, 2018. HB 2249 will be heard in Senate Judiciary on Thursday, March 8, 2018 at 9:00 am.

HB2247 passed the House of Representatives with a vote of 58-0 on February 8, 2018. HB 2247 will be heard in Senate Judiciary on Thursday, March 8, 2018 at 9:00 am.

IV. Review ACJC Legislative Positions

Jaime Watson provided a status update on ACJC supported bills, including HB 2001 (Indigent Defense Fund; Distribution; Purpose) and SB 1350 (Indigent Defense Fund; Distribution; Purpose). HB 2001 passed the House of Representatives with a vote of 42-16 and was referred to Senate Judiciary and Appropriations. There is no update on SB 1350 and was not heard in committee by the deadline and will be removed from future agendas.

Jaime Watson provided a status update on ACJC opposed bills, including SB 1078 (Arizona Criminal Justice Commission; Membership), SB 1244 (Membership; Arizona Criminal Justice Commission), SB 1345 (Criminal Justice Commission; Legislative Recommendations), and HB 2511 (Criminal Justice Commission; Membership; Report). There is no update on ACJC's opposed bills and each bill was not heard in committee by the deadline and they will be removed from future agendas.

Jaime Watson provided a status update on ACJC monitor bills, including SB 1035 (Municipal Courts; Maximum Revenue; Transfer), SB 1061 (Medical Marijuana Fund; Appropriation), HB 2069 (Private Prisons; Contracts; Termination), HB 2313 (Sentencing; Monetary Obligations; Fine Mitigation), HB 2415 (Juvenile Dependency Proceedings Fund), SB 1186 (Injunction Against Harassment; Petition; Hearing), SB 1400 (Aggravated DUI; Sentence; County Jail), SB 1496 (Prisoners; Drug Sentences; Out-of-Custody Treatment), and HB 2640 (Sexual Assault Victims; Study Committee). SB 1035 was not heard in committee by deadline and will be removed from future agendas. SB 1061 came back as a strike everything amendment added to SB 1282. HB 2069 was not heard in committee by deadline and will be removed from future agendas. HB 2313 passed the House of Representatives with a vote of 56-0 and referred to Senate Judiciary. ACJC will continue to monitor. HB 2415 passed the House of Representatives with a vote of 51-7 and referred to Senate Appropriations and Judiciary Committee. ACJC will continue to monitor. SB 1186 was used as a vehicle for an unrelated strike everything amendment, which failed to pass the Senate with a vote of 18-12. The bill will be removed from future agendas. SB 1400 passed the Senate 30-0 and will be heard in House Judiciary and Public Safety. A floor amendment in the sponsor's name was adopted which would require a sheriff who establishes a DUI program to report the necessary data to the ACJC for the required recidivism report. SB 1496 passed the Senate with a vote of 30-0, as amended and referred to House Appropriations and House Military, Veterans and Regulatory Affairs. Joe Brugman motioned to oppose SB 1496 as written with ability to move to neutral, if amended and Mark Napier seconded the motion. The motion carries. HB 2640 was not heard in committee by deadline and will be removed from future agendas.

V. Review Introduced Criminal Justice Legislation

Jaime Watson presented the following criminal justice legislation to the Committee for review, discussion, consideration and possible action on support of various criminal justice legislation:

1) SB 1282 (Technical Correction; Bingo License; Transfer)

A strike everything amendment, had been introduced which would appropriate \$5,000,000 from the Medical Marijuana Fund to the ACJC in FY 2019 to administer as drug control grants. The bill has not gone before the Committee of the Whole and will need ¾ vote to pass due to Prop 105 regulations.

Joe Brugman motioned to monitor and Mark Napier seconded the motion. The motion carried.

Chief Sanders made a call to the public. No members of the public addressed the Committee.

I. Call to Order and Roll Call

The meeting was called to order by Chief David Sanders at 1:37 pm. Roll was taken and a quorum was not declared present.

II. Minutes of the March 2, 2018 Meeting

Due to a lack of a quorum, vote to approve could not be completed.

III. Review of Introduced Criminal Justice Legislation

Director Andy LeFevre stated we were in day 18 of the legislative session with a total of 964 bills being introduced.

Director LeFevre discussed the bills that would place a requirement on ACJC, these bill include HB2206 Sexual Assault Victims; Study Committee (not assigned) and HB 2245 Mandatory Minimum Sentences; Judicial Discretion (1/28 assigned to House Judiciary). Director LeFevre discussed HB 2171 Indigent Defense Fund; Distribution; Purpose (1/28 assigned to House Judiciary and House Appropriations) and HB 2277 Indigent Defense Fund; Distribution; Purpose (1/28 assigned to House Judiciary and House Appropriations).

Director LeFevre brought SB 1380 Criminal Justice Commission; Membership; Report to the committee's attention. This bill seeks to add one public defender, one crime victim advocate, and one representative from a nonprofit organization that provides services to former prison inmates, and remove one law enforcement leader, one mayor, and one member of a county board of supervisors. This bill has not been assigned to a committee at the current time, but staff will keep the commission appraised of the status of this bill.

Staff will continue to monitor all Title 13 bills being introduced.

Director Byers discussed HB 2052 Juveniles; Detention Centers; Dangerous Offenses. This bill addresses a juvenile who is charged with or arrested for a "dangerous offense" (defined elsewhere in statute) is no longer prohibited from being detained in a juvenile detention center. Director Byers indicated that when the joint committees are able to take formal action that he requests that it vote to support HB2052.

Director Ryan discussed HB 2266 Prisoners; Transition Program; Eligibility. This is a cleanup bill from last year's SB 1496. Director Ryan also raised concerns about SB 1358 Prisoners; Visitation; Healthcare; Ombudsman and the requirements that it would place on the Department of Corrections by way of micromanaging the internal operations of the facilities.

Due to a lack of a quorum, Director LeFevre will solicit the joint committee members' input on various bill positions via email and report back the vote count.

VI. Call to the Public

Chief Sanders made a call to the public. No members of the public addressed the Committee.

VII. Date, Time, and Location of Next Meeting

The next legislative update will be February 15, 2019 at 1:30 PM.
