I. Call to Order and Roll Call

The meeting was called to order by Chief David Sanders at 1:32 pm. Roll was taken and a quorum was declared present.

II. Minutes of the March 2, 2018, January 18, 2019, and February 1, 2019 Meetings

Jerry Landau entered a motion to approve the minutes of the meeting held on March 2, 2018. The motion was seconded by Director Charles Ryan and was unanimously approved by the Committee.

Jerry Landau entered a motion to approve the minutes of the meeting held on February 1, 2019. The motion was seconded by Director Charles Ryan and was unanimously approved by the Committee.

III. Review of Introduced Criminal Justice Legislation

Molly Edwards, Public Information Officer/Legislative Liaison stated we were in day 33 of the legislative session with a total of 1,289 bills being introduced. Next week is the final week for hearing bills in their houses of origin. Over the next two weeks staff will have a better idea of how many bills will be moving.

Edwards provided a summary of the bills that staff is tracking, the support bills include HB 2052 (Juveniles; Detention Centers; Dangerous Offenses), HB 2171 (Indigent Defense Fund; Distribution; Purpose). HB 2266 (Prisoners; Transition Program; Eligibility), HB 2267 (Prisoner Accounts; use; ADOT Credentialing), HB 2277 (Indigent Defense Fund; Distribution; Purpose), SB 1092 (Prisoners; Transition Program; Eligibility), SB 1093 (Prisoner Accounts; use; ADOT Credentialing). Edwards noted that HB 2052 and HB 2171 were not moving. Additionally, Edwards stated that SB 1380 (Criminal Justice Commission; Membership Report) and SB 1422 (Criminal Justice Commission; Membership Report) have been assigned to Senate Judiciary, but neither has received a hearing.

Director LeFevre provided an update on SB 1250 (Sexual Assault Protective Order) introduced by Senator Steele. This bill, as introduced, seeks to create a new protective order process for victims of sexual assault. Last session, the Commission approved HB 2249, which reformed the States Orders of Protection and Injunctions of Harassment process. Staff met with Senator Steele and representatives from the Arizona Coalition to End Sexual and Domestic Violence to address the current law which states that if a person is a victim of sexual assault by an individual that they do not have a relationship with, the only protection that they seek is covered under the Injunctions of Harassment statute. The statute says, "Instances (plural) mean they would have to be a victim of sexual violence more than once to be able to seek protection from the court." Working with the Senator and the representatives from ACESDV, staff was able to draft a fix to this issue that could be accomplished in the existing Injunctions of Harassment statute that would only need one instance (instead of two) in order to seek protection from the courts for that matter. Director LeFevre asked the joint committee members for approval to treat this language as an ACJC priority bill and to allow staff to continue to work to incorporate this amended language into this bill. LeFevre has had an initial conversation with Chairman Farnsworth and he seems amenable to considering the proposed language.

Steve Williams made a motion to authorize staffs continued work on SB 1250 as presented to the committee members. Director Charles Ryan seconded the motion. Motion passed unanimously.

Staff will continue to monitor all Title 13 bills being introduced.

VI. Call to the Public

Chief Sanders made a call to the public. No members of the public addressed the Committee.

VII. Date, Time, and Location of Next Meeting

The next legislative update will be March 1, 2019 at 1:30 PM.
