A public meeting of the Joint Executive Legislative Committee convened on **March 15, 2024**, at the Arizona Criminal Justice Commission office, 1110 W. Washington, Suite 230, Phoenix, AZ 85007.

1. Call to Order and Roll Call

At 1:30 p.m., the meeting was called to order by **Chief David Sanders**, **Ana Maris** conducted the roll call, and a quorum was established.

2. Minutes of the March 8, 2024 meeting

During the Committee meeting, **Chief David Sanders** requested a motion to approve the minutes. The motion was put forward by **Designee Rebecca Baker** and was unanimously approved by the Committee, with **Director David Byers** seconding the motion.

3. Update and Review of ACJC priority legislation

Molly introduced some newly tracked bills. SB1208 was mentioned last meeting and involves restricting telecommunication. This bill is of concern to the Committee and **Designee Rebecca Baker** mentioned that it might be dead since it was not scheduled for a committee hearing in the House. SB1216 restricts government agencies from monitoring their employees' web usage. There was an amendment added onto this bill.

A. Update on SB1117

During the meeting, **Molly Edwards** updated the Committee on SB1117, which is being heard in House MAPS on March 18th. Representative Payne is running an amendment that defines an "approved criminal justice agency".

B. Update on HB2716

Molly stated that this bill will be heard in Senate MAPS on March 20th as amended.

c. **Update on HB2243**

Molly stated that the Commission has signed in support of this bill and it has moved through the majority and minority caucuses in the Senate.

d. **Update on HB2782**

Molly summarized HB2782 and stated that it failed House third read on March 4th, but was brought back for reconsideration and received Do Pass in House COW on March 12th. ACJC is still trying to get in contact with the bill's sponsor to get clarification on some of the Commission's concerns.

4. Review Introduced Criminal Justice Legislation

Molly Edwards stated that ACJC has not had any luck getting in contact with the Secretary of State to talk about HB2743, but the Commission will be talking with the bill's sponsor on March 19th. ACJC is also trying to reach out to Representative Livingston in hopes to get the amendment removed or changed and redirect their plans for funding somewhere else. **Steve Stahl** explains why the ARPA funding is being spent the way it is. **Designee Rebecca Baker** notified the Committee that the bill is not scheduled on any committee agenda for the following week so the bill may die. **Director David Byers** brought up the concern that the committee should not revert to failing to spend the money after fighting against the bill. **Molly** stated that SB1003 is moving with no amendments, many individuals are signed in opposition to it, and it will most likely not be assigned to a committee in the House. HB2593 was scheduled for the Senate Government committee on March 14th, has multiple amendments added onto it, and **Molly** mentioned that this is a bill the Committee should be watching because it places requirements on state agencies such as ACJC. HB2134 and SB1408 are mirror bills. Both are moving, law enforcement is in support of these bills

5. Call to the Public

There were no emails or calls from the public.

6. Date, Time, and Location of Next Meeting
