I. Call to Order and Roll Call

The meeting was called to order by Chief David Sanders at 1:30 pm. Roll was taken and a quorum was present.

II. Approval of Minutes from March 5, 2021

Blaze Baggs made the motion to approve the minutes. Liana Garcia seconded the motion. Motion passed unanimously.

III. Legislative Overview

Molly Edwards, Public Information Officer/Legislative Liaison stated there is another week of committee hearings and then another week after that for appropriations hearings. Then budget bills will be introduced.

Ms. Edwards announced that HB2166 passed the Senate and is now on the Governor's desk for signature. Staff sent a letter over to the Governor's office asking for his support.

HB 2260 Arizona Criminal Justice Membership bill, staff is still on a holding pattern on this bill.

HB2158: The Protective Orders; Central Repository- AOC and DPS continue to have discussions on how to resolve the issues on this bill. Hopeful amendment language can be met in the coming week.

HB2168, Use of Force bill, noted that the bill now states January 2023 and we are hopeful that the data will be collected beyond the date that ACJC's system becomes operational.

HB2190: Criminal Justice Case Information- was referred to House Judiciary on March 2nd, but has not received a hearing.

HB2295 – The Brady bill- maybe going to the floor and we will continue to monitor.

HB2713 – Earned Release Credits bill. Staff sent report from the DOC out to the committee for the impacts of this bill should it pass. Has been referred to Senate Judiciary, but has not received a hearing as of yet.

HB 2810- Civil Asset Forfeiture bill – Passed Senate Judiciary and Rules. Staff will continue to monitor this bill.

Ms. Edwards explained there are four bills that list ACJC as the fiscal agent. Of the four bills, three are moving. Of the three, one had an amendment on it. We will continue to monitor.

Chief Sanders inquired about the Earned Release Credits bills and wondered if ACJC had a chance to review the data on this. Ms. Edwards stated that we had not, but the AOC has been looking at the impacts should it pass. Ms. Ptak also stated that the Board of Clemency is also closely monitoring any of the earned release credit bills. Chief Sanders further stated that if it passed it would impact parole in many counties, especially Maricopa County.

Ms. Ptak stated that 2165 continues to be put on the calendar and removed. The Home Arrest program and it also has a significant fiscal note. It will need a financial appropriation.

This concludes the legislative report.

IV. Call to the Public

Chief Sanders made a call to the public. No members of the public were present.
