ACJC Deputy Director Tony Vidale reviewed for Members those funds that staff anticipate will be available for re-distribution under the Arizona Coronavirus Emergency Supplemental Funding Grant program due to agencies de-obligating funds that went unspent under the grant program cycle. This presents a challenge to try and re-allocate these funds within a narrow window before the full grant program cycle ends for ACJC. Staff provided a recommendation on an initial re-distribution of funding to 13 agencies totaling \$198,284.74. The Members discussed how best ACJC can run a process to be transparent and still ensure compliance with the federal grant requirements and meet the deadline imposed by the CESF grant.

Commissioner Byers Moved to approve the recommended re-allocation of funds in the amount of \$198,284.74 to the named agencies. The motion was seconded by Commissioner Sanders and passed unanimously with Chairperson Stahl voting yes for Ms. Polk.

The Executive Committee approve the staff recommendation to re-allocate \$1,591,476.76 in unexpended Coronavirus Emergency Supplemental Funding as displayed in table 2 with the grant ending on January 31, 2023.

Recommendation

Staff is recommending the re-allocation of \$1,591,476.76 in unexpended Coronavirus Supplemental Funding to the agencies listed in table 2. These funds must be expended by January 31, 2023. In addition, the staff is requesting a provision be inserted into the grant agreement that requires the recipient agency to submit documentation by August 1, 2022 showing all supplies and equipment approved for purchase under the grant have been ordered. If supplies and equipment are not ordered by August 1, 2022, the Commission may terminate the grant agreement.

Background

The Arizona Coronavirus Emergency Supplemental Funding (ACESF) Program established the overarching goal to prevent, prepare, and respond to the coronavirus' impact on the Arizona criminal justice system. This grant program focuses on short-term, immediate criminal justice system needs and long-term needs that will develop as a result of COVID-19. Short-term needs are centered on law enforcement officers, detention/corrections officers, and probation officers that are at high risk of COVID-19 due to their contact with the public and prosecutors, public defenders, and court personnel involved in current casework. Items such as personal protective equipment, overtime, sanitizer, medical expenses for inmates, and technology equipment are a priority. Long-term needs address issues such as case backlog issues, technology equipment to handle increased workload capacities, additional staffing needs, and unforeseen or unpredicted COVID-19 issues.

The source of funding for the Arizona Coronavirus Emergency Supplemental Funding Program is a federal grant from the Coronavirus Emergency Supplemental Funding Program FY 2020 Formula Grant (CFDA #16.034) administered by the U.S. Department of Justice, Bureau of Justice Assistance (BJA).

Funding

Grant funds were awarded in June of 2020 to 54 agencies totaling \$11,187,183. The grant performance period was from January 2020 until January 2022. At the end of the performance period, \$1,789,761.50 remained unexpended by recipient agencies. If these funds are not expended by January 31, 2023, they must be returned to the federal government. In order to expedite the approval process for these unexpended funds, the staff went before the Executive Committee for approval of an initial expenditure plan of \$198,284.74 to Victim Compensation Programs and the Arizona Prosecuting Attorney's Advisory Council for equipment and pandemic related supplies. In addition, the Executive Committee directed staff to make the remaining unexpended funding, \$1,591,476.76, available to agencies under a limited grant opportunity. Agencies were notified of the opportunity and the grant opened on March 14, 2022 and closed on April 1, 2022. Thirty-four agencies applied for funding with requests totaling \$8,138,174.54. Table 1 shows the requests submitted by agencies. Table 2 shows the staff recommendation for the re-allocation of funding.
