RECOMMENDATION:

The Executive Committee recommend to the full Commission the allocation of \$11,187,184 in federal funds for grants allocated to state, county, local, and tribal criminal justice agencies and non-profit agencies that provide services to the criminal justice system in Arizona as part of the Arizona Coronavirus Emergency Supplemental Funding Program.

DISCUSSION:

As part of the CARES Act, the Arizona Criminal Justice Commission, as the designated State Administering Agency for federal Byrne JAG funding, received a federal grant from the Coronavirus Emergency Supplemental Funding Program FY 2020 Formula Grant (CFDA #16.034) administered by the U.S. Department of Justice, Bureau of Justice Statistics.

The grant provided \$11,187,184 in funding to be distributed to local, county, state, and tribal agencies in order to help them prevent, prepare, and respond to the coronavirus' impact on the criminal justice system.

ABOUT THE ARIZONA CORONAVIRUS EMERGENCY SUPPLEMENTAL FUNDING PROGRAM

The Arizona Coronavirus Emergency Supplemental Funding (ACESF) Program established the overarching goal to prevent, prepare, and respond to the coronavirus' impact on the Arizona criminal justice system. This grant program focuses on short-term, immediate criminal justice system needs and long-term needs that will develop as a result of COVID-19. Short-term needs are centered on law enforcement officers, detention/corrections officers, and probation officers that are at high risk of COVID-19 due to their contact with the public and prosecutors, public defenders, and court personnel involved in current casework. Items such as personal protective equipment, overtime, sanitizer, medical expenses for inmates, and technology equipment are a priority. Long-term needs address issues such as case backlog issues, technology equipment to handle increased workload capacities, additional staffing needs, and unforeseen or unpredicted COVID-19 issues.

The source of funding for the Arizona Coronavirus Emergency Supplemental Funding Program is a federal grant from the Coronavirus Emergency Supplemental Funding Program FY 2020 Formula Grant (CFDA #16.034) administered by the U.S. Department of Justice, Bureau of Justice Assistance (BJA).

FUNDING

The Commission set a program size of \$11,187,184 in federal funds for multiple grants allocated to state, county, local, and tribal criminal justice agencies and non-profit agencies that provide services to the criminal justice system.

There is **no match** requirement for this grant.

All projects funded under this program are for 24 consecutive months starting January 20, 2020, and ending January 20, 2022.

Priority consideration was given to:

- Law enforcement agencies, corrections/detention agencies, probation offices, and other public safety agencies that are in direct contact with the public.
- Agencies and organizations that are not eligible for the direct award of CESF funds from BJA.
- Prosecutor offices, public defender offices, and courts that must come into direct contact with the public due to current case processing demands.
- Expenditures for supplies that prevent the spread of the coronavirus among personnel or facilities.
- Overtime expenditures resulting from staffing shortages due to the coronavirus.
