#### **I. Call to Order, Roll Call and Pledge of Allegiance**

The meeting was called to order by **Vice Chairperson Joe Brugman** at 1:31 pm who led the Pledge of Allegiance. **Wendy Boyle** was asked to take a roll call, and a quorum was declared present.

#### **II. Commission Presentation on ODMAP Tool by Jeff Beeson, Washington/Baltimore HIDTA**

**Jeff Beeson** presented on the overdose mapping digital tool that allows first responders to log an overdose in real time into a centralized database. The tool enables capturing all fatal and nonfatal overdose incidents on a shared data platform across agencies and the country. The ODMAP tool gives law enforcement agencies real-time information about overdose occurrences and trends that allows them to shape a more effective opioid response.

#### **III. Minutes of the March 21, 2019 Meeting**

**Vice Chairperson Brugman** called for a motion on the minutes of the Commission meeting held on March 21, 2019. **Commissioner Williams** entered a motion to approve the minutes. The motion seconded by **Commissioner Duggan** was unanimously approved by the Commission.

#### **IV. Executive Director's Report**

##### **1. Staff and Program Updates**

**Executive Director LeFevre** informed the Commission that there are two postings for positions at ACJC. Program Manager Larry Grubbs has resigned leaving the Program Manager for Victim Services open, and a job opening for a shared grant coordinator position for the Drug and Systems Improvement programs. ACJC is looking at other grants to apply and other grant opportunities with juvenile corrections as well as activities such as the problem gambling grant through the Department of Gaming and the COAP (Comprehensive Opioid Abuse Prevention). In the Statistical Analysis Center (SAC), ACJC has extended an offer to an applicant for a research analyst position, and there were two promotions - Jillian Ware as acting SAC director and Jaimie Jeffords, Ph.D., as Research Director for SAC. Also, two interns are working at ACJC this summer, Joanne Mae Atrero in the drug program and Andrew Vargas in the SAC department.

##### **Finance Update**

**Executive Director LeFevre** reported that staff continues for the end of the fiscal year to continue balancing funds and keep appropriate levels as well as estimating incomes, revenue, and outgoing expenses.

#### **V. Committee Reports**

##### **A. Executive**

##### **1. Update on the activities of the Executive Committee**

**Executive Director LeFevre** addressed that both he is working on the creations of a review process for the Executive Director and that Chairperson Polk will be calling a meeting of the Committee to review the process before it is released to the Commission for review.

##### **2. Update on Statistical Analysis Center Projects**

**Jillian Ware, Interim SAC Director**, updated the Commission on several of the research projects that (SAC) is currently working on. The data requests completed for AYS 2018 and both Jillian and Dr. Jaimie Jeffords gave presentations for HIDTA, Arizona Juvenile Justice Commission and the Casa Grande Alliance. In the process of final the contracts with ASU on AYS 2020 that includes questions and a sampling strategy. Consulting with the representative at the Attorney General's office to review the data request policy. Led a meeting with the law enforcement partners to solicit feedback in the 2018 survey to finalize the survey instrument. Participated in the Arizona Gang Investigator's Conference to promote the gang threat assessment and ACJC's grant administration programs. Providing data and support at the NICS task force meetings in April and July, as well as providing data for grant solicitations, and delivering data for the Drug, Gang and Violent Crime Control Strategy. Dr. Jeffords is working with the Substance Abuse Epidemiology Work Group that is part of the Arizona Substance Abuse Partnership developing a statewide data profile – Risk and Protective Factor Scale, Social Determinants of Health and Data Collection.

**B. Drug, Gang and Violent Crime Control**

**1. Update on the activities of the Drug, Gang & Violent Crime Committee**

**Chairperson Brugman** referred to Tony Vidale, Deputy Director and Program Manager, to update the Commission. At the April 25, 2019 meeting, the Committee was presented the Cycle 33 grant awards for the Drug, Gang, and Violent Crime Control Program as well as the updated FY2019 DGVCC grant awards and FY2019 RSAT grant. There was also a status report on the statewide strategy that will be completed and sent for approval at the Commission meeting in November as well as the completion and approval of the five-year report to the Governor Regulatory Review Council.

**2. Drug, Gang, and Violent Crime Control Program Cycle 33 Grant Awards**

**Tony Vidale** presented the recommendation from the Committee for the Drug, Gang & Violent Crime Control grant funds displayed on page 19 of the agenda contingent on receiving federal funding. **Commissioner Duggan** entered a motion to approve the award of \$9,100,970 of the Arizona Drug, Gang & Violent Crime Control Cycle 33 grant funds to eligible criminal justice agencies contingent on receipt of federal funds for the period beginning July 1, 2019, and ending June 30, 2020, except the Attorney General's Office Medicaid Fraud project, which funds from October 1, 2019, and ending September 30, 2020. The motion seconded by **Commissioner Stahl** was unanimously approved by the Commission.

**C. Crime Victims**

**1. Update on the activities of the Crime Victims Committee**

**Chairperson Ryan** referred to Mr. Vidale to update the Commission. At the May 8, 2019 meeting, ACJC staff presented the FY20 Crime Victim Assistant Grant Program and the redistribution of Victim Compensation funds allocated to the county program.

**2. Crime Victim Assistance Grant Program**

**Mr. Vidale** presented the recommendation of the Crime Victims Committee to allocate from Crime Victim Assistance grant awards totaling \$750,000 for FY20. Staff became aware of allegations made against one of the applicants, Never Again Foundation that was in consideration of receiving funding, and the case was fraudulent use of organizational funds. ACJC compliance and program staff went on a site visit to try and determine the status of the grant and liability. The Committee discussed two options: Choose to fund, by June 30<sup>th</sup>, and provide information to ACJC to satisfactorily meet the criteria established in the application, and have ACJC staff include special conditions, have financial controls in place for the grant agreement or the fund will go to Homicide Survivors.

**Commissioner Ryan** entered the following motion. 1.) Approve the award of FY20 Crime Victim Assistance grant funds for \$750,000 in FY20 Crime Victim Assistance grant funds as outlined in Table VS-1 to eligible victim assistance projects for the period beginning July 1, 2019, and ending June 30, 2020. 2.) Accepting the modifications to shift from Never Again Foundation, the amount of \$44,780 to zero balance and change the amount to Homicide Survivors from \$29,100 to \$73,880 to fund a 0.5 legal advocate and a 0.5 civil attorney. The motion seconded by **Commissioner Stahl** was unanimously approved by the Commission.

**3. Crime Victim Compensation Program**

**Mr. Vidale** presented the recommendation of the Crime Victims Committee that the Commission approves the available compensation funds for the current FY19 is reallocated to operational units by Table VS-3 on page 26 of the agenda. **Commissioner Stahl** motioned to approve the reallocation of FY19 victim compensation funds by Table VS-3 using the county allocation funds sources totaling \$80,000 in state compensation benefits funding. The motion seconded by **Commissioner Sanders** was unanimously approved by the Commission.

**D. Information Technology Systems Improvement**

**1. Update on the activities of the Information Technology Systems Improvement Committee**

**Marc Peoples, Program Manager** commented the Committee has not met since February 2019. The updates to projects include the Order of Protection System – They are working on how to provide the Protection Order to law enforcement once the court issues the Protective Order. ACJC staff will be conducting meetings in August around the state to disseminate information to law enforcement about the changes and rules. On the ADRS project, Navajo County is ready to send data in real time, and Maricopa County will go live on July 1<sup>st</sup>.

**E. Legislative**

**Update on the activities of the Legislative Committee**

**Chairperson David Sanders** reported the Committee met every other Friday during the legislative session and bills supported were received favorably by the Commission.

**1. Update on 2019 Legislative Session Bills and FY2020 State Budget Negotiations**

**Molly Edwards, Public Information Officer**, reviewed the legislative update for this past session. The legislature has been in assembly now for 130 days, there were 1,317 bills, including the budget bills with 250 signed into law, 14 are within the criminal code, and three within the prisons. A current budget sheet for ACJC as well as the bill-tracking document so far as of May 23, 2019, was given to the Commission for review. A legislative summary will be processed and completed by the meeting in July.

## **FY 2021 Budget Issues**

### **State Aid to Indigent Defense – Fill the Gap**

In 1999 the Arizona enacted Fill the Gap legislation in order to provide additional resources to county attorneys, indigent defense agencies, and superior courts to assist in their efforts to reduce case processing times throughout the state. Since FY 2012, the state legislature has redirected the revenue in the State Aid to County Indigent Defense Fund to the Arizona Attorney General's Office and/or the Arizona Department of Public Safety.

This loss of state funds has negatively impacted county programs and their ability to fund case processing and have made it nearly impossible for counties to meet the Arizona Supreme Court mandated timeframe for processing cases. ACJC is requesting authority to allocate available funds to county programs as intended by law.

### **Implementation of New RICO Reporting Requirements**

Two new laws enacted during the 2018 legislative session greatly expanded the reporting requirements for agencies that deal with civil asset forfeiture activities and created an entirely new report dealing with forfeiture orders. Both reports are mandated to be in an electronic format and reported on a quarterly basis. It is ACJC's understanding that that intent of this new requirement for an electronic format is so that greater transparency is provided for RICO expense information for the agencies that participate, and so that the expense information can be accessed and searched by the legislature and state agencies that choose to do so.

As the state agency statutorily mandated to collect and distribute the comprehensive state-wide RICO reports, ACJC is requesting \$100,000 for FY 2019 in order to hire a web developer/database programmer to create the necessary web interface and database architecture to handle the new reporting requirements. These costs break down as follows: \$30,000 for the expanded expense reporting requirements and \$70,000 for the new forfeiture order reporting requirements.

ACJC does not have an agency budget that can absorb these costs from existing funding sources. In addition, ACJC is not currently able to determine the ongoing administrative costs to house and maintain these new systems as they grow year over year with the large amounts of new data being added. These costs may also need to be addressed in future budget requests to the Executive and Legislature.

### **State General Fund Support for Statewide Victim Notification System**

As part of the 2018 legislative session, the Commission introduces and was successful in enacting HB 2249, which undertook the first comprehensive re-write of the State's orders of protection/injunction against harassment process. Language included in the enacted legislation, allows for the establishment of a state-wide victim notification system to provide plaintiffs real-time information on their case.

ACJC is seeking federal grant funds to allow for the establishment of a state-wide victim notification system. Grant funds can be used for the initial purchase and integration of a system, but will not allow for continued yearly upkeep and maintenance costs associated with the the operation of such a system. ACJC is seeking an appropriation from the general fund to support the yearly maintenance cost of a state-wide victim notification system that will allow for system-wide efficiency savings and enhances access for victims to services and information.

## **Continued Decline in Criminal Justice Enhancement Fund Revenue**

The Commission is increasingly concerned with the continued decline in revenues into the Criminal Justice Enhancement Fund that is used to fund a wide range of critical criminal justice activities in Arizona. From FY2008 to FY2018, CJEF revenue has declined 29.5 percent from \$47.8 million to 33.7 million. This decline in revenue has resulted in agencies like the Arizona Peace Officers Standards and Training Board and the Arizona Prosecuting Attorneys' Advisory Council (both of which are fully funded by CJEF) having to significantly reduce services to their stakeholder. In addition, declining revenue into CJEF impacts other critical criminal justice programs like county jail enhancement funding, crime lab operations, drug treatment programs, programs targeted at juvenile offenders, and victim services.

The Commission established a working group to look at this issue which was chaired by Chief Sharp from the Oro Valley Police Department. The working group consisted of members from the Department of Public Safety, AZ POST, Arizona Prosecuting Attorneys Advisory Council, ACJC, and Yavapai County Attorney, Sheila Polk. This group met over the past 18 months to gain a better understanding of what was driving the continued decline in CJEF revenue and to lay out some potential funding solutions to help fill the approximately \$15 million in lost funding since the 2008 fiscal year. As a result of the activities of the work group, the Commission at its July 18, 2018 meeting approved pursuing several possible funding fixes during the 2019 legislative session. These include:

- 1. The Commission develop a budget issue/request to the Executive to earmark a portion of new revenue derived from sales tax on internet sales to go towards criminal justice activity funding in general and the CJEF specifically.**
  - As this is new revenue for the state it presents the best possibility for providing new funding for criminal justice activities. The recent Supreme Court ruling opens this as a new potential \$200 million per year revenue stream for the state.
- 2. Additional fees on either cell phone sales or monthly bills** (nexus now that the legislature has passed a ban on texting and driving for new drivers)
  - Based on national calculations, 95% of people over the age of 18 own a cell phone. In Arizona, this equates to approximately 5 million cell phones. An additional fee/surcharge of \$.10/line/month could generate approximately \$6 million in additional revenue per year. An additional fee/surcharge of \$.15/line/month could generate approximately \$9 million in additional revenue per year.
- 3. Additional fees on either car or homeowners insurance policies** (theft claims involve the criminal justice system)
  - In 2017 there were approximately 5.1 million insured vehicles in Arizona. An additional .50 surcharge on vehicle insurance policies could generate approximately \$5 million in additional revenue per year (much like the Auto Theft Authority is funded)
  - In 2017 there were approximately 2.9 million housing units in Arizona. An additional \$2 surcharge per homeowners insurance or renters policy per year could generate approximately \$6 million in additional revenue per year.
