I. Call to Order and Roll Call

The meeting was called to order by Dave Byers at 2:03 p.m. The roll was taken, and a quorum was declared present.

II. Approval of Previous Meeting Minutes from March 17th, 2022

Chairperson Dave Byers called for a motion on the minutes. Julio Marroquin entered a motion to approve the minutes of the meeting held on 3/17/22. The motion was seconded by Phil Dougherty and was unanimously approved by the Technical Team.

III. Update on Current CJ Systems Improvement Project

A. AZPoint - Orders of Protection

Lloyd Asato, Criminal Justice Systems Improvement Program Manager, provides a status update on AZ Point. Enhancements to AZPoint has been funded and begun. Competition date is expected in 2023.

B. VINE - Victim Notification Project

Lloyd Asato, Criminal Justice Systems Improvement Program Manager, provides an update on the Victim Notification System. Four counties have equipment set up and

training has been completed. Maricopa County is in process of being set up and the current big focus. Towards the end of 2022 it is estimated that the first five counties will be online.

C. HB 2166 Data Project Phase 1

Andy LeFevre, Executive Director, updates the committee on the Data Project HB 2166. Data has been collected to get an idea on the cost. Phase II is starting and future stakeholder meetings are set up for later this month.

D. Arizona Disposition Reporting System (ADRS)

Lloyd Asato, Criminal Justice Systems Improvement Program Manager, provides an update on ADRS. Six counties are currently live. The remaining counties are being reengaged and testing will begin soon.

IV. Technology and Policy Teams Chair

Lloyd Asato, Criminal Justice Systems Improvement Program Manager, discussed the Tech and Policy teams have not been standing committees but used to provide guidance and feedback on future projects.
