III. Crime Victim Services Program Rules Revision

Larry Grubbs presented a brief description of the rules making process to this point and proposed a process for reviewing and discussing the proposed changes by the committee. Mr. Faull indicated he felt there was a need for additional review of all items at a future date with the inclusion of data on the administration and programmatic, financial impacts of the changes. The committee discussed the type of additional information Mr. Faull felt was needed and the impact of delaying action. Mr. Grubbs explained that additional data would need to come from the operational units as ACJC would not have direct access to this information. Mr. Grubbs supplied an alternative timeline for implementation of rule changes if a recommendation for how to proceed the proposed rule changes was not arrived at during the current meeting. Mr. Faull proceeded to enter a motion that the items be tabled and the new proposed timeline be adopted to allow time for operational units to supply ACJC with the necessary data. The motion was seconded by Amy Bocks and was unanimously approved by the Committee.
