Pursuant to Arizona Revised Statute (A.R.S.) § 38-431.02(F), notice is hereby given to the Trustees of the Arizona State Retirement System (ASRS) Appeals Committee (AC) and to the general public that the ASRS AC will hold a meeting open to the public on Tuesday, December 12, 2017, beginning at 9:30 a.m., in the 10th Floor Board Room of the ASRS offices at 3300 N. Central Avenue, Phoenix, Arizona 85012. Trustees of the Committee may attend either in person or by telephone conference call.

This is a regularly scheduled meeting of the AC; however, due to possible attendance by other ASRS Board Trustees, this meeting may technically become a meeting of the Board or one of its committees. Actions taken will be consistent with the AC governance procedures. Actions requiring Board authority will be presented to the full Board for final decision.

Pursuant to A.R.S. § 38-431.03(A)(3), the ASRS AC may vote to go into executive session, which will not be open to the public, for the purpose of obtaining legal advice on any item on the agenda.

As a result of public comment, the AC may direct staff to study and/or reschedule the matter for discussion and decision at a later date.
