This a notice that the Citizen’s Transportation Oversight Committee (CTOC) is scheduling a meeting open to the public on **Thursday**, the **9th** day of **February, 2017**, at **3:00 PM**.

Pursuant to the A.R.S. 28-6356, the Citizen’s Transportation Oversight Committee may discuss and take actions on all matters relating to the Regional Transportation Plan in the county. The committee can make recommendations to the Regional Planning Agency, the Regional Public Transportation Authority, and the State Transportation Board regarding transportation projects and public transportation systems funded in the Regional Transportation Plan, the Transportation Improvement Program, ADOT Five Year Construction Program, and the Life Cycle Management Program. The committee may also consult with the Auditor General on matter of performance auditing and make recommendations to the Regional Planning Agency, the Regional Public Transportation Authority, the Department, the Speaker of the House of Representatives, the President of the Senate and the Governor.
