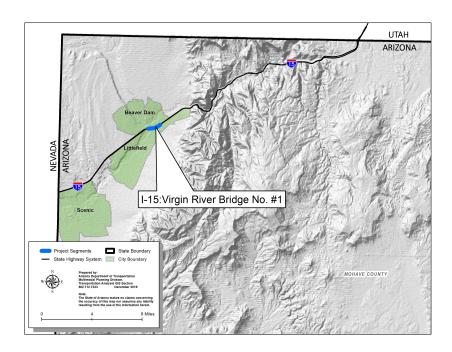

26. JUSTIFICATION OF REQUEST

The Virgin River Bridge #1 project is currently under design and the geotechnical investigation for the 3 span bridge is underway. During the field investigation the drilling sub-consultant came across rough conditions which led them to exhaust more than 80pct of the allotted man hours on the first of four borings. Funding is needed to cover the additional work that will be performed to wrap up the geotechnical investigation.

Funding is also needed for additional cultural investigations tied to the material borrow site needed for the construction access road, and additional design work performed by the CMAR to provide the footprint of the temporary bridge needed for construction access.

Funding is also needed to cover staff efforts in acquiring the TCE.

Staff = \$86kConsultant = \$202k ICAP = \$29k

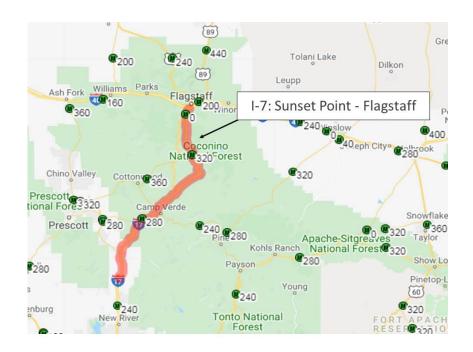

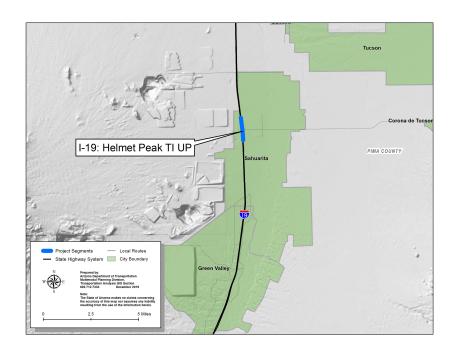

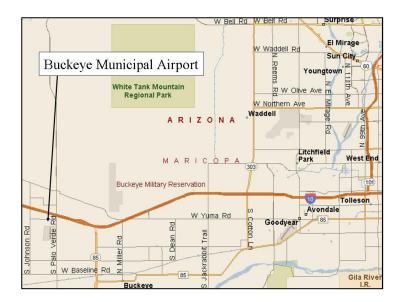
