The Scoping phase (01L)is non-Federal aid funding, Development and Construction has the potential to be funded using Federal Aid. ADOT and the City of Flagsatff (CoF) evaluated alternatives for construction methods of the 4th St Bridge. Accelerated Bridge Construction method of Bridge Slide was recommended to be the most beneficial for the public. It will reduce overall construction duration by two months and will reduce vehicular closure on 4th street by three months to make it a one season project. Additional design efforts are needed to incorporate this change. This work is estimated to be \$154K and is equally split between ADOT and CoF (\$77K Each). CoF has requested aesthetics and paid for design work on the 4th St Bridge.
