Pursuant to A.R.S. §38-431.02, notice is hereby given to the members of the Navigable Stream Adjudication Commission and to the public that the Navigable Stream Adjudication Commission will hold a meeting open to the public Wednesday September 19, 2018 at 9:00 a.m. in Senate Hearing Room 3, 1700 West Washington, Phoenix, Arizona 85007

Pursuant to A.R.S. § 38-431.03(A)(3), the Navigable Stream Adjudication Commission may vote to go into Executive Session for purposes of obtaining legal advice from the Commission's attorney on any matter listed on the agenda, or pursuant to A.R.S. § 38-431.03(A) or for discussion of records exempt by law from public inspection on any matter listed on the agenda.

Title 2 of the American with Disabilities Act (ADA) prohibits the Commission from discriminating based on disability in its public meetings. The corrections to the report on the Verde River are as follows (<u>underlining</u> represents insertions; strikethough represents deletions): Page 50, line 18: "Proponents must show that it is more likely than not that the Verde Gila River..."

Page 51, line 4: "See Winkleman, 224 Ariz. at 243, 229 P.3d at 255..."

Page 54, lines 8-9: "The Verde River in Cochise, Pima and Pinal Yavapai, Gila, and Maricopa Counties, Arizona..."

Page 62, lines 2-5: "and determines that the Verde River from its headwaters at Sullivan Lake to the confluence with the Salt River, in Yavapai, Gila and Maricopa Counties, Arizona Salt River from the confluence of the White and Black Rivers, to its confluence with the Gila River, was not navigable..."
