
**21. Executive Session (The Commission will not vote to take on any action during Executive Session).**

- c. - d. Legal Advice.** The Commission may vote to meet in executive session in accordance with A.R.S. § 38-431.03(A)(3) for the purpose of discussing and consulting with legal counsel for legal advice regarding the Commission's authority to close state trust lands to hunting and to close roads providing access to state trust lands.
- e. One or more members of the Commission may appear and participate in the meeting telephonically or by other electronic means.*
