ADOT'S NONDISCRIMINATION NOTICE TO THE PUBLIC

The Arizona Department of Transportation (ADOT) hereby gives public notice that it is the Agency's policy to assure full compliance with Title VI of the Civil Rights Act of 1964, Title II of the Americans with Disabilities Act of 1990 (ADA), and other related authorities in all of its programs and activities.

ADOT's Title VI and ADA Programs require that no person shall, on the grounds of race, color, national origin, or disability, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity.

Any person, who believes his/her Title VI or ADA rights have been violated, may file a complaint. Any such complaint must be in writing and filed with the ADOT Civil Rights Office within one hundred eighty (180) days following the date of the alleged discriminatory occurrence. Los programas del Título VI y ADA de ADOT exigen que a ninguna persona se le excluya de participar, se le nieguen beneficios o de ninguna otra manera sea sujeta a discriminación en ningún programa o actividad de ADOT por motivo de raza, color, país de origen, o discapacidad.

The Statewide Mobility Analytics in Real-Time (SMART) tool is the creation of a team from the Smart Transportation Lab at the University of Arizona. The two-year procurement contract is broken into two phases (separated by FY23 and FY24) and will have the UA team bring in new data sources such as social media and safety records to the platform, and develop predictive analytics. In addition to continuing operations, minor upgrades, and documentation for the system, the first phase will focus on improving the accuracy of the wrong-way detection system and integrating social media data to analyze for public sentiment and identification of roadway obstructions.
