NOTICE OF MEETING OF THE ARIZONA STATE BOARD OF DENTAL EXAMINERS’ ANESTHESIA AND SEDATION COMMITTEE

Pursuant to Arizona Revised Statute (“A.R.S”) § 38-431.02, notice is hereby given to the members of the Arizona State Board of Dental Examiners’ (“Board”) **Anesthesia and Sedation Committee** (“Committee”) and to the general public that the Committee will hold a meeting open to the public on **Tuesday, August 2, 2022 at 2:30 p.m.** The meeting will be held in virtual and telephonic formats. Members of the public may also participate virtually or telephonically. However, during the course of the meeting, the Committee, upon a majority vote of a quorum of the members, may, when necessary, hold an executive session pursuant to A.R.S. § 38-431.03(A)(2) and/or (3) as indicated on the Committee’s Agenda. The executive session is not open to the public.

The Committee may address the agenda items in any order within the time frame, if any, indicated and may set over matters to a later time when necessary. The Committee reserves the right to change the order of the agenda items, except for matters set for a specific time.

All meeting attendees whose presence is not required in an executive session will be required to leave the meeting room during executive session. Any and all legal action will take place in open session.

II. REVIEW, DISCUSSION AND POSSIBLE ACTION ON COMMITTEE MEETING MINUTES

III. NOTICE OF PROPOSED RULEMAKING (“NPR”)

Committee to review, discuss and take possible action to recommend that the Board approve the draft NPR for submission to the Governor’s Regulatory Review Council, including proposed changes to Title 4, Chapter 11, Articles 1, 3, 4, 12 and 13, which include amendments to the Board’s anesthesia and sedation rules.

Committee to review and discuss the monitoring and credentialing requirements for Anesthesia Assistants and take possible action to make a recommendation to the Board.

V. DENTAL ASSISTANTS

Committee to review and discuss regulation and duties for Dental Assistants and take possible action to make a recommendation to the Board.

VI. AGENCY SUBSTANTIVE POLICY STATEMENT

Committee to review and discuss Agency Substantive Policy Statement #28 and take possible action to incorporate it with the NPR.

VII. ANESTHESIA AND INTRAVENOUS SEDATION COMMITTEE

After reviewing and discussing CVs/résumés of possible committee members to fill the committee vacancy, the Committee may take possible action to recommend that the Board approve and appoint the Committee's selection(s).

VIII. STUDY/REVIEW OF ADVERSE OCCURRENCE REPORTS

Committee to review and discuss adverse occurrence reports collected on a single spreadsheet to help identify issues or concerns that may necessitate statutory and/or rule changes. Upon a vote of the majority of a quorum, the Committee may go into executive session, pursuant to A.R.S. § 38-431.03(A)(2) to discuss or consider records exempt, by law, from public inspection, including the receipt and discussion of information or testimony that is specifically required to be maintained as confidential by state or federal law.

IX. SUMMARY OF CURRENT EVENTS

By law, the summary of current events is limited to summarizing recent occurrences. The Board cannot propose, discuss, deliberate or take legal action on any matter in the summary unless the specific matter is properly noticed for legal action.
