OF THE ARIZONA STATE BOARD OF DENTAL EXAMINERS’ ANESTHESIA AND SEDATION COMMITTEE

Pursuant to Arizona Revised Statute (“A.R.S”) § 38-431.02, notice is hereby given to the members of the Arizona State Board of Dental Examiners’ (“Board”) **Anesthesia and Sedation Committee** (“Committee”) and to the general public that the Committee will hold a meeting open to the public on **Friday, August 11, 2023 at 2:00 p.m.** The meeting will be held in virtual and telephonic formats. However, during the course of the meeting, the Committee, upon a majority vote of a quorum of the members, may, when necessary, hold an executive session pursuant to A.R.S. § 38-431.03(A)(2) and/or (3) as indicated on the Committee’s Agenda. The executive session is not open to the public.
