**2. AFA Resolution No 2024-35** – The Authority’s proceedings granting final approval of not-to-exceed \$35,000,000 combined aggregate principal amount of Multifamily Housing Revenue Bonds (The Acacia at Youngtown Phase II Project) and Multifamily Housing Revenue Note (The Acacia at Youngtown Phase II Project), each to be issued in one or more tax-exempt and/or taxable series, for the benefit of Acacia Two Owner LLC.

3. **AFA Resolution No 2024-36** – The Authority’s proceedings granting final approval of not-to-exceed \$85,000,000 aggregate principal amount of Multifamily Housing Revenue Bonds (Maricopa 2.0 Project), to be issued in one or more tax-exempt and/or taxable series, for the benefit of IH Maricopa Apartments Owner II LLC (formerly known as Roers Maricopa Apartments Owner II LLC).

4. **AFA Resolution No 2024-37** – The Authority’s proceedings granting final approval of not-to-exceed \$82,000,000 aggregate principal amount of Multifamily Housing Revenue Bonds (Goodyear Apartments Project), to be issued in one or more tax-exempt and/or taxable series, for the benefit of IH Goodyear Apartments Owner I LLC.

5. **AFA Resolution No 2024-38** – The Authority’s proceedings granting final approval of not-to-exceed \$85,000,000 aggregate principal amount of Multifamily Housing Revenue Bonds (Casa Grande Family Apartments Project), to be issued in one or more tax-exempt and/or taxable series, for the benefit of IH Casa Grande Apartments Owner II LLC (formerly known as Roers Casa Grande Apartments Owner II LLC).

6. **AFA Resolution No 2024-39** – The Authority’s proceedings granting final approval of not-to-exceed \$61,000,000 aggregate principal amount of Multifamily Housing Revenue Bonds (Casa Grande Senior Apartments Project), to be issued in one or more tax-exempt and/or taxable series, for the benefit of IH Casa Grande Senior Apartments Owner II LLC (formerly known as Roers Casa Grande Senior Apartments Owner II LLC).

7. **AFA Resolution No 2024-40** – The Authority’s proceedings granting final approval of not-to-exceed \$29,500,000 aggregate principal amount of Revenue Bonds (Mosaic Project), Series 2024, to be issued in one or more tax-exempt and/or taxable series, for the benefit of Mosaic.

3. **Consider for Approval: Strategic Planning Services** – Presentation, discussion, and board action on a proposal from the Council of Development Finance Agencies to provide consulting and strategic planning services.
