Consider for Approval: Resolution No. 2024-50** – Presentation, Discussion and Board Action on a Resolution granting preliminary approval of not-to-exceed \$78,000,000 of multifamily housing revenue bonds, notes or other obligations to be issued in one or more tax-exempt and/or taxable series, to finance a multifamily qualified residential rental project in Phoenix, Arizona, for the benefit of Lincoln Avenue Communities, LLC, on behalf of a yet-to-be-formed tax credit limited liability company or partnership.

6. **Consider for Approval: Resolution No. 2024-51** – Presentation, Discussion and Board Action on a Resolution granting preliminary approval of not-to-exceed \$20,000,000 of multifamily housing revenue bonds, notes or other obligations to be issued in one or more tax-exempt and/or taxable series, to finance a multifamily qualified residential rental project in Buckeye, Arizona, for the benefit of Buckeye Leased Housing Associates III, LLLP.
