#### AGENDA

In December of 2018, ASRS's Information Protection and Security project was approved to reduce risk of personal identifiable information data loss. The original timeline was November 2019 through June 2024. ASRS is coming to ITAC with a Change Request to extend that date to June 2025 and a budget surplus of \$1.3M

### Staff & Inmate Monitoring and Tracking RFID System - DC23029

In January 2024 the Arizona Department of Corrections Reentry and Rehabilitation (ADCRR) project was approved with the injunction requiring installation of a comprehensive Radio Frequency Identification (RFID) system within restricted movement locations across state complexes, to track both inmate and staff movement in complex detention and mental health wards. ADCRR is returning with a Change Request for approval on the WIFI/Network as a Service component that was also part of the original injunction.
