Welcome to a meeting of the Arizona State Transportation Board. The Transportation Board consists of seven private citizen members appointed by the Governor, representing specific transportation districts. Board members are appointed for terms of six years each, with terms expiring on the third Monday in January of the appropriate year.

# **BOARD AUTHORITY**

Although the administration of the Department of Transportation is the responsibility of the director, the Transportation Board has been granted certain policy powers in addition to serving in an advisory capacity to the director. In the area of highways the Transportation Board is responsible for establishing a system of state routes. It determines which routes are accepted into the state system and which state routes are to be improved. The Board has final authority on establishing the opening, relocating, altering, vacating or abandoning any portion of a state route or a state highway. The Transportation Board awards construction contracts and monitors the status of construction projects. With respect to aeronautics the Transportation Board distributes monies appropriated to the Aeronautics Division from the State Aviation Fund for planning, design, development, land acquisition, construction and improvement of publicly-owned airport facilities. The Board also approves airport construction. The Transportation Board has the exclusive authority to issue revenue bonds for financing needed transportation improvements throughout the state. As part of the planning process the Board determines priority planning with respect to transportation facilities and annually adopts the five year construction program.

# PUBLIC INPUT

Members of the public may appear before the Transportation Board to be heard on any transportation-related issue. Persons wishing to protest any action taken or contemplated by the Board may appear before this open forum. The Board welcomes citizen involvement, although because of Arizona's open meeting laws, no actions may be taken on items which do not appear on the formal agenda. This does not, however, preclude discussion of other issues. MEETINGS

The Transportation Board typically meets on the third Friday of each month. Meetings are held in locations throughout the state. Due to the risks to public health caused by the possible spread of the COVID-19 virus at public gatherings, the Transportation Board asks that people attending Board meetings in person take safety precautions they feel appropriate to protect themselves and others. In addition, for the time being the Transportation Board will conduct concurrent telephonic/WebEx virtual meetings. In addition to the regular business meetings held each month, the Board may conduct at least one public hearings each year to receive input regarding the proposed five-year construction program. Meeting dates are established for the following year at the December organization meeting of the Board.

# **BOARD MEETING PROCEDURE**

Board members receive the agenda and all backup information one week before the meeting is held. They have studied each item on the agenda and have consulted with Department of Transportation staff when necessary. If no additional facts are presented at the meeting, they often act on matters, particularly routine ones, without further discussion. In order to streamline the meetings the Board has adopted the "consent agenda" format, allowing agenda items to be voted on en masse unless discussion is requested by one of the board members or Department of Transportation staff members.





#### REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA STATE TRANSPORTATION BOARD:

The Infrastructure Delivery and Operations Division has made a thorough investigation concerning the establishment and improvement of the Nogales - Tucson Highway, Interstate Route 19, within the above referenced project.

The existing right of way was previously established by various resolutions placed of record over the years by the Arizona State Highway Commission, and/or its successor, the Arizona State Transportation Board, which became the governing body of the State Transportation System on July 01, 1974.

New right of way is now needed to be utilized for the reconfiguration of the Irvington Road Traffic Interchange to enhance convenience and safety for the traveling public.

Accordingly, it is necessary to acquire and establish the new right of way as a state route, and that access be controlled as necessary for this improvement project.

The new right of way to be established as a state route and acquired for this improvement, including access control as necessary, is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Infrastructure Delivery and Operations Division, Phoenix, Arizona, entitled: "Stage III Design Plans, dated October of 2024, NOGALES - TUCSON HIGHWAY, I-19 Irvington Road T.I., Project 019 PM 061 F0488 / 019-A(243)T".

In the interest of public safety, necessity and convenience, I recommend that the new right of way depicted in Appendix "A" be

13	of the Board and staff. As mayor of Pinetop-Lakeside, I would
14	just like to officially welcome you to our community. I hope
15	you're enjoying your stay up here and the hospitality we have to
16	offer for you.
17	I would really like to thank you for your support
18	for the recent SMART grants that Pinetop-Lakeside was awarded.
19	We've gotten two, one of them for the Woodland Road project
20	(indiscernible) and Highway 260, as well as the bridge over
21	Billy Creek at Pinetop Commons.
22	I can't even imagine what you guys are going
23	through trying to spread your precious resources around the
24	whole state, and I do appreciate what you're doing for the whole
25	White Mountains as well as rural Arizona. There's been some

1	great projects approved, and we appreciate your support, and we
2	appreciate the teamwork working with you and working with your
3	staff to accomplish a lot of this.
4	So welcome to God's country. I hope you enjoy
5	your stay, and we look forward to having you back anytime you
6	want to come. So thank you very much.
7	CHAIRMAN SEARLE: Thank you, Mayor.
8	MR. ROEHRICH: Our next speaker is Mayor John
9	Leech, Junior. Mayor Leech.
10	MAYOR LEECH: Stephanie just took my speech. So
11	I also want to welcome you. We appreciate you guys being here,
12	being back up on the mountain. I remember most of you a few
13	months ago when you had your meeting in Show Low. So welcome
14	back.
15	Thank you for everything you do, are doing for
16	our community. Sometimes it seems like rural Arizona gets left
17	out of some of these projects, and I know there's a lot of work
18	going on, and it's kind of strange, because people complain
19	about our roads, and when we work on them, they complain we're
20	working on them. So I get it, what you're going through, but
21	thank you again for everything you do for rural Arizona. If you
22	guys need anything whatsoever, let us know. Welcome.
23	CHAIRMAN SEARLE: Thank you.
24	And I think we do have a Show Low project that's
25	on the agenda. Maybe we should make it challenging this time

2	MR. ROEHRICH: Our next speaker is Mr. Vinny
3	Gallegos.
4	MR. GALLEGOS: Good morning, Mr. Chairman,
5	members of the Board. In solidarity, no jacket, no tie,
6	Chairman, so happy to join the group with you.
7	You know, in light of the Mayor's comment about
8	rural Arizona, this is a great opportunity to remind all of us
9	that excuse me in three months we're going to have the
10	25th Arizona Rural Transportation Summit, and to the Mayor's
11	point, this was started 25 years ago for that very purpose. It
12	was decided then and we've continued for the last 25 years that
13	if rural Arizona comes together, stays together, in addition
14	with our partners in greater Maricopa, greater Pima County, that
15	we can tackle transportation issues.
16	You know at your last meeting in Flagstaff, you
17	all were starting to participate in a really active discussion
18	regarding transportation funding, transportation policy, and
19	what are those things that can be done. So I want to again
20	re-invite you and those in attendance and those virtually to
21	really come join us in Prescott, October 16th through the 18th.
22	The purpose of this conference is really one of a
23	kind in Arizona. It's the one conference that brings the topics
24	solely focused on transportation and the decision makers into
25	the room, and we're really going to take the time over those

2	that, able to leave there with some start of a plan. And you
3	all were talking at your last meeting. Well, what does that
4	look like? When do we start that? Who's doing that?
5	I would invite you to use the rural summit as
6	that springboard for that exact conversation. We're not going
7	to tackle it in two days. We haven't got here in two days, but
8	I will argue that that is one great opportunity to gather with
9	about 400 attendees. Half of those are about legislators.
10	We're working hard to get our state legislators there right now.
11	I sent out invites to 50 of them. Heard back from almost 20 of
12	them, which is great news. We know they're busy. We know they
13	have busy schedules, but they are making efforts to be there.
14	You know, we've heard already from many on the
15	transportation committees in the Senate and the House, so some
16	of the very key people have committed to be there. So again,
17	look forward to you seeing you there, people like the Mayor
18	and others that really want to bring a voice to rural
19	transportation. I hope we do that, but I hope we bring a voice
20	to transportation in all of Arizona. So again, thank you very
21	much.
22	CHAIRMAN SEARLE: Thank you, Mr. Gallegos.
23	MR. ROEHRICH: Mr. Chairman, those are the
24	requests I have for in person. Online, I have two requests.
25	Our first speaker is Mayor Nancy Smith. Mayor Smith, please

1	raise your hand.
2	WEBEX HOST: Ms. Smith, if you could please raise
3	your hand. That's the same star three or the raised hand signal
4	on the bottom of your screen.
5	MR. ROEHRICH: Bryce, do you see her as a
6	participant?
7	WEBEX HOST: I'm scrolling through right now.
8	MR. ROEHRICH: I don't see her now that I look
9	through this.
10	WEBEX HOST: Yeah. I don't see her as well.
11	MR. ROEHRICH: Our next then next speaker will
12	be Mr. Ron Angerame, and I do see he's on there.
13	Mr. Angerame, please raise your hand.
14	WEBEX HOST: I have requested to unmute your
15	line. You are now unmuted.
16	MR. ANGERAME: Great. Can am I being heard?
17	I just want to make sure that you guys can hear me.
18	WEBEX HOST: Yeah, we can hear you.
19	MR. ROEHRICH: Yes, sir. We can hear you. Go
20	ahead.
21	MR. ANGERAME: Wonderful. Thank you.
22	My name is Ron Angerame. I'm from Maricopa, and
23	I appreciate the opportunity to address the Board, to talk to
24	you about State Route 347. I've distributed to you a set of
25	press articles highlighting some of the recent accidents on

1	State Route 347. Hopefully you've received my PowerPoint.
2	As you can see, the safety issues on driving 347
3	continue to escalate. Not even the police cars are safe. I've
4	also included a summary of the accidents over the past ten years
5	on State Route 347 using ADOT data. This does not include 2024
6	data. As you can see on Slide 3, there have been 35 fatal
7	accidents resulting in 43 fatalities, 49 suspected serious
8	injury accidents, 363 suspected minor injury accidents, 372
9	possible injury accidents, and 1,706 accidents without injury,
10	for a grand total of 2,524 accidents over the ten-year period.
11	If we take an average over these past ten years
12	and look at delaying the required improvements on State
13	Route 347 by two years, we can expect 74 possible injury
14	accidents, 72 suspected minor injury accidents, 10 suspected
15	serious injury accidents, and 8 or 9 people will die. Not
16	delaying the improvements on State Route 347 will substantially
17	help you reach your strategic highway safety plan goals of 20
18	percent.
19	Finally, in my last call to the public talk, a
20	board member made a comment that I should talk to my legislator.
21	I did that and was advised that the reason for the two-year
22	delay was ADOT was, quote, not ready, so it didn't make sense to
23	budget State Route 347 in the new fiscal year. I am strongly
24	urging ADOT to contract whatever resources or reprioritize other
25	projects and please do whatever is necessary to accelerate the

1 required work on 347. Thank you. 2 CHAIRMAN SEARLE: Thank you, Ron. And we did get your -- your PowerPoint was forwarded to us. 3 MR. ROEHRICH: Our next speaker -- Bryce, I see 4 that there's a call-in user that's a panelist. Is that 5 Ms. Peshlakai? 6 7 WEBEX HOST: You know, I'm not sure. They are 8 muted, but they do -- they did have the panelist code, so I 9 didn't move them over. 10 MR. ROEHRICH: Can we check with them? Call-in 11 user, could you identify who you are, please? Shows their 12 microphone's active. Is that not correct? 13 WEBEX HOST: Yeah, you are correct. I could --14 I'm not hearing anything from them, though. 15 MR. ROEHRICH: Call-in user, can you please 16 identify who you're -- who you are? 17 WEBEX HOST: I can move them over since they're 18 not speaking. MR. ROEHRICH: Well --19 20 MR. LIGOCKI: Floyd, this --21 MR. ROEHRICH: Yes, sir. Who is this? 22 MR. LIGOCKI: Floyd, this is Clem Ligocki. This 23 is Clem Ligocki. I have called in. MR. ROEHRICH: Okay. Clem, we're going to go 24 25 ahead and mute you, please, so we'll continue on.

1	MR. LIGOCKI: Yeah. I'm sorry. I didn't
2	recognize I was coming in that way. Thank you.
3	MR. ROEHRICH: Okay. Thank you, Clem.
4	Our next speaker, Mayor Nancy Smith. Mayor
5	Smith, have you logged in to the meeting? Because I did not see
6	her, Bryce. I don't know if you saw. I don't believe she has
7	logged in.
8	WEBEX HOST: Yeah. I don't see her still as
9	on the attendant list.
10	MR. ROEHRICH: So, Mr. Chairman, that's all the
11	requests to speak that I have. If Mayor Smith would log in,
12	I'll try to monitor that, and if you would open it again for
13	comments later on, that would be fine. It's your choice, but if
14	not, she's not here not now, that's the end of call to the
15	audience.
16	CHAIRMAN SEARLE: All right. Very good. Then I
17	will go ahead and close the call to the audience and move on to
18	Item Number 1, our director's report. I understand, Director
19	Toth, you are online?
20	DIRECTOR TOTH: Yes, sir.
21	CHAIRMAN SEARLE: All right. The podium is
22	yours.
23	DIRECTOR TOTH: Thank you. I apologize for not
24	being there today. I'm a little under the weather, and Floyd
25	decided he didn't want me in his car, so

1	
1	I just want to thank the Town for welcoming us
2	today and definitely wish I could have been there today.
3	So I'll start with some celebratory news. This
4	month ADOT marks its 50th anniversary. In July of 1974,
5	Arizona's Aeronautics and Highway Departments were combined to
6	create the Arizona Department of Transportation. And to mark
7	that milestone, we've been having a lot of fun looking back.
8	I'd invite you to check out our ADOT blog and our social media
9	channels for some great content, including photos from archives
10	and the lots of great history.
11	Just to give you an idea of how far we've come,
12	back in 1974, there were about 5,800 miles of state highway, and
13	the interstate system on in Arizona was only 86 percent
14	complete. Since then we've added more than 1,100 miles to the
15	state's transportation system, and we celebrated the completion
16	of Interstate 10's final mile almost 35 years ago.
17	And not only is ADOT celebrating a milestone, but
18	it's also the State Transportation Board's 50th anniversary. So
19	the State Transportation Board met for the very first time at
20	noon on July 1st, 1974. The new board consisted of four members
21	from the existing Highway Commission and three members from the
22	state's Aeronautics Board. So it's been really fun looking back
23	on that history as a department.
24	So moving on, I want to congratulate Arizona
25	Highways magazine for earning 16 awards for excellence in

1 visuals, writing and production at the -- at their most recent 2 annual international regional media association conference. We 3 asked Kelly Mero of the Highways magazine if he left any other 4 awards for any other magazines, but the magazine won three first 5 place gold awards, six silver awards, and four bronze awards, 6 and three merit awards. The magazine was founded in 1925, so 7 next year we're going to be celebrating their 100th anniversary. 8 Arizona Highways has subscribers in all 50 states and more than 9 100 countries. We're very proud of the work that the team is 10 doing. Glad to see them receive this recognition. 11 I want to give you a quick update on State 12 Route 88, the interim project, which is the section that was 13 damaged by flooding in 2019. Thanks to the Board's funding 14 approval earlier this year to restore limited access to five 15 miles of that damaged Apache Trail, we've been able to make a 16 lot of progress. As you'll recall, we've had some of our 17 maintenance crews doing vegetation removal and culvert cleaning, 18 and they have regraded part of the road and backfilled the 19 washouts, and then upon the Board's approval today, we 20 anticipate starting the construction part of that in late July. 21 We'll begin the interim project -- or we expect the project to 22 be completed this fall, and then we'll be able to reopen that 23 five-mile stretch of State Route 6- -- State Route 88. Sorry.

68, that's my past history -- near Fish Creek Hill for use -they'll be able to be accessed by UTVs or high clearance four-

1 wheel drive vehicles.

Just last week we released our 2023 Motor Vehicle Crash Facts Report, which compiles traffic crash reports from law enforcement agencies across the state. It reflects crash data for all of Arizona roads, not only ADOT roads, but city streets, county roads, tribal roads, and also the state highway system.

8 So what we saw is that last year traffic 9 fatalities in the state decreased slightly, but we are still near an all-time high. In total, there were 1,307 traffic 10 11 fatalities across the state last year, which was a decrease of 12 .98 percent compared to 2022. The numbers show that crashes 13 associated with alcohol impairment and speeding continued to be 14 the leading causes of death and injuries, which was an important 15 reminder for all drivers to avoid unsafe driving behaviors.

16 Other statistics from the report show there were 17 fewer pedestrian and bicyclist fatalities in 2023. Our 18 pedestrian fatalities fell by 12.3 percent, and bicyclist 19 fatalities were 10.2 percent lower than in 2022.

So we know that every fatality represents someone's loved ones. At the agency, we're continuing to work with our partners around the state on safety strategies, but we definitely need everyone using the roads to work together to reduce these preventable crashes.

Talking about -- also about safety, last month I

1	shared some tips for drivers on preventing vehicle-caused
2	wildfires. This month I'll end my update with a quick reminder
3	about driving in the summertime's extreme heat. It's always
4	important to be prepared for the unexpected. So make sure you
5	have a fully charged cell phone. Bring extra drinking water
6	with you in the vehicle. Drivers should also consider bringing
7	things like an umbrella for shade or sun protection. We think
8	of rain, but we need it here for sun protection. Make sure you
9	have a first aid kit and a flashlight. If you're embarking on a
10	longer drive, a travel tool kit and battery cables are also good
11	to have.
12	While we haven't had much of a monsoon season so
13	far, it's always good to know what to do in case of a dust
14	storm. We always advise drivers to pull off the roadway. You
15	should pull off the road, turn off your lights and make sure to
16	take your foot off of the brake so that people don't think that
17	you're driving in that lane. We want everyone to stay safe this
18	summer. And with that, I'll hand things over for the
19	legislative report. Thank you.
20	CHAIRMAN SEARLE: Thank you.
21	Before we go to the legislative report, are there
22	any questions for Director Toth? Ms. Daniels.
23	VICE CHAIR DANIELS: Director Toth, I haven't
24	seen the data yet that you've referenced early on in safety. Is
25	there a note in there or a data set that would indicate the age

1	of drivers that is most impacted by both fatality and accident?
2	And the reason that I'm asking that is I continue
3	to believe that perhaps additional driver training and a higher
4	threshold for driver safety and capacity is might be one of
5	our ways of improving safety on our roadways. I've always been
6	a little shocked watching my own children get their driver's
7	license and wondering if they're actually really ready for that,
8	given the number and amount of training that they've had, and so
9	I point at myself as a parent as well. But is there any data
10	that indicates that this may be a component of our safety
11	traffic safety data set?
12	DIRECTOR TOTH: We can definitely look at that
13	and provide you information.
14	VICE CHAIR DANIELS: Thank you.
15	CHAIRMAN SEARLE: Ms. Howard, Mr. Meck, any
16	questions for the director?
17	MS. HOWARD: I do have a quick question,
18	Director. On the SR-88, what's left after this five miles is
19	rehabilitated? How much how many more miles do we have left
20	for full access?
21	DIRECTOR TOTH: So with those five miles, that
22	will provide like I said, it's the interim project, where
23	UTVs, you know, high clearance vehicles, four-wheel drives are
24	able to access it. Remember the larger full project is about
25	\$33 million, and so we will continue to apply for grants to be

1	able to do the full project, but the entire stretch of 88 would
2	be open to four-wheel drives after this project, this interim
3	project.
4	MS. HOWARD: Okay. Thank you.
5	CHAIRMAN SEARLE: Have one more question,
6	Ms. Daniels?
7	VICE CHAIR DANIELS: This isn't something you
8	referenced, Director Toth, but I did receive a letter from
9	Sandra Watson, the executive director of the Arizona Commerce
10	Authority. As an ACA board member, she was notifying the Board
11	about the economic strength projects, and the reason I wanted to
12	sort of bring this up at the beginning of the meeting is because
13	I know we have some elected officials in the room who may not be
14	able to stay for the entire time, but those economic strength
15	projects are the ones that are in partnership with ADOT but
16	awarded through a different not awarded, but approved through
17	a different body and brought forward to ADOT in partnership.
18	There's four of those that are looking to be funded this year.
19	Do you know when or if we as a board will be voting on those to
20	move those forward?
21	DIRECTOR TOTH: I will look into that and find
22	out.
23	VICE CHAIR DANIELS: Okay. It's the Taylor
24	Cessna Loop Road project, City of Kingman's Industrial Park Road
25	reconstruction project, the City of Bullhead City's Highway 95

1	deceleration lane, and then Mohave County's Cane Beds Road
2	resurfacing. So those are the four items.
3	DIRECTOR TOTH: We might have the answer in the
4	room. No? I won't call you out.
5	MR. ROEHRICH: They're talking about some other
6	subject. They're getting ready for the next presentation. Is
7	that it? Yeah.
8	CHAIRMAN SEARLE: Okay.
9	VICE CHAIR DANIELS: Apologies.
10	CHAIRMAN SEARLE: If there are no other questions
11	for Director Toth, we'll go ahead and go to the legislative
12	update.
13	MR. ROEHRICH: Director, I do not see Anthony on
14	here, and I don't know if yeah. He was on leave, so I don't
15	know if there is a legislative update.
16	CHAIRMAN SEARLE: Okay. Very good. If there is
17	not an update, and we have no other questions for Director Toth,
18	we'll move to Item Number 2, which is our district report with
19	Mr. Wilson.
20	MR. ROEHRICH: If I could break in, I've got two
21	requests. Ms. Peshlakai did send us a message saying conflicts
22	came up. She will not make the meeting even virtually. She's
23	unable to attend.
24	CHAIRMAN SEARLE: Okay.
25	MR. ROEHRICH: So she will not be here for the

2	And Bryce, could you move Chris Kett up to a
3	panelist, please, from the participant list?
4	WEBEX HOST: Yes. One moment.
5	MR. ROEHRICH: Thank you.
6	CHAIRMAN SEARLE: Mr. Wilson.
7	MR. WILSON: Good morning. First I'd like to
8	thank the Board for traveling up to this wonderful country that
9	we love up here. I'd like to thank the Town of Pinetop-Lakeside
10	for hosting, and I'd like to and I just appreciate you came
11	to visit the Northeast District. So I'm going ahead and get
12	started.
13	Next slide, Chris.
14	All right. This first project is the Teesto Wash
15	Bridge on State Route 87. It is constructed by SEMA
16	Construction. It's a \$6.9 million project, and this project
17	included the complete replacement of the bridge, and it's
18	current it's currently substantially complete.
19	Chris, next one.
20	All right.
21	MR. ROEHRICH: Ed, could you wait for a minute?
22	Because we're having the WebEx has not caught up.
23	MR. WILSON: Okay.
24	MR. ROEHRICH: So who who's sharing the
25	presentation to the WebEx? Is that here

1	WEBEX HOST: That's me. I'm sorry. One second.
2	MR. ROEHRICH: No problem. I know we were having
3	a problem here, Bryce, so actually, we're having a problem
4	trying to share it. Could you please show it, but then could
5	you advance the slides when when Ed asks for it, please?
6	WEBEX HOST: Yes, of course.
7	And then who was the panelist you wanted me to
8	move over.
9	MR. ROEHRICH: Chris Kett, K-e-t-t. Thank you.
10	WEBEX HOST: All right. We're all set. Sorry
11	for the technical issues.
12	MR. ROEHRICH: I'm sorry we're having difficulty
13	here. I was not able to present. Give us one minute, sir. So
14	you're able to present? Okay.
15	(Inaudible conversation.)
16	MR. ROEHRICH: I've got it here. No. I think
17	Chris got it.
18	Okay. Thank you, Mr. Chairman and Board Members
19	for us working through that. Thank you, Bryce. We'll handle
20	the presentations here. Sorry, Ed.
21	WEBEX HOST: Wonderful.
22	MR. WILSON: So this project is the Coyote Wash
23	Bridge. It's being constructed by Vastco Construction. It's a
24	\$4 million project. This project involves replacement of the
25	superstructure, which is the girders, the deck and everything

1	
1	above the girders, on top of the existing abutments and piers.
2	So the project is being constructed half at a time, and we
3	finished the first half, the first deck pour yesterday for the
4	first half of the bridge, so we're about we're approaching
5	the halfway mark on that one.
6	So next slide.
7	All right. This project's on 377 from the 277
8	junction to the Forest Boundary, and it's being constructed
9	it's a life extension project, being constructed by Cactus
10	Asphalt. It's a \$1.7 million project. So the project really
11	involves doing spot repairs to the pavement, micro milling off
12	the entire top surface of the roadway and placing a micro cape
13	seal, which is a chip seal with the micro seal on top of it.
14	And currently we have the micro milling and all the spot repairs
15	completed and the chip seal completed, and we're just waiting to
16	a little cure time to do the micro seal on top.
17	So next slide.
18	This is the on 260 over by Heber, the
19	Overgaard to Camperland. It is being constructed by the VSS
20	International is the prime contractor. It's a \$1.4 million
21	project. This is another life extension project. It includes
22	micro milling the existing surface and placing the micro cape
23	seal like the last project was. And currently, we've finished
24	the micro milling right now. We have some spot repairs that
25	we'll make after that and then have to place the chip seal and

1	micro seal coming up, so
2	And the next one.
3	CHAIRMAN SEARLE: That was quick.
4	MR. WILSON: Wow.
5	MR. ROEHRICH: Are there any questions?
6	MR. WILSON: And in conclusion.
7	CHAIRMAN SEARLE: Iqbal, see how that was done?
8	MR. HOSSAIN: Yeah. That's how we do it.
9	MR. WILSON: All right. So our next project here
10	is the Pinta to McCarrel project. So this project was combined
11	with the Dead River Bridge eastbound project under one contract.
12	It's Fann Contracting is our prime contractor of this
13	\$30 million project. That's the combined project amount. So
14	the Pinta to McCarrel project section is a pavement
15	rehabilitation project. It also includes replacing the bridge
16	barrier and approach slabs at the Crazy Creek Bridge westbound,
17	sealing all the decks on the crossroad TI bridges of Pinta,
18	Navajo and McCarrel, replacing the guardrail, doing concrete
19	spillways and other minor work. So currently, this project is
20	just working on all the minor work right now. They're doing all
21	the guardrail and the bridge seals, and the work at Crazy Creek
22	is about halfway completed, and they'll start the paving portion
23	of it in a few weeks.
24	Next slide.
25	So this is the Dead River Bridge portion of that

1 project on the eastbound bridge. This is ADOT's first effort in 2 placing an ultra high performance concrete deck overlay. So the project (indiscernible) includes hydrodemolition of the top two 3 inches of the bridge deck, then utilizing the ultra high 4 performance concrete overlay to replace that material. And 5 6 we're also going to replace the approach slabs and some other 7 minor working bridge at the time. 8 So the ultra high performance concrete is pretty interesting stuff. It's actually 18,000 PSI material, which is, 9 10 you know, about four times the strength of our -- of our 11 standard concrete. It has some steel fibers in it so that we'll 12 really control the crackage in it. It's very low permeability, 13 so it won't allow much water intrusion, and with all those 14 factors, it should be a very, very, very durable surface to have 15 on top of this bridge. 16 Is this something, technology CHAIRMAN SEARLE: 17 that -- being used elsewhere? 18 MR. WILSON: Yes. It's being used quite a bit, 19 especially back east, but it's our first effort into this on a They have poured some smaller items like deck joints and 20 deck. 21 stuff with it, but this is the first time to do a deck for ADOT. 22 CHAIRMAN SEARLE: And there's a cost benefit? I mean, it's --23 24 MR. WILSON: Yeah. There's an increased 25 participation from FHWA from this innovative effort.

1	CHAIRMAN SEARLE: Thank you.
2	MR. WILSON: Uh-huh. And really, the while we
3	were pretty well having breakfast this morning is when they
4	finished pouring the deck. So it's coming right along.
5	So the next slide.
6	So here's just some upcoming projects that we
7	have. So the Business 40 Crestview to Joy Nevin project in
8	Holbrook is a pavement rehabilitation project. It opened July
9	12th and was read at \$2.1 million.
10	The US-191 project at Little Colorado River
11	Bridge to Cemetery Road in St. Johns is a pavement
12	rehabilitation project that opened back on June 14th, and it was
13	read at \$583,000.
14	The State Route 77 project, Taylor to Rodeo Road
15	in Snowflake is to install curb, gutter and sidewalk for that
16	section of road. It's let's see. And actually, its bid
17	opening is today. So it's about ready to go, and it's
18	programmed at \$2.9 million.
19	The next project is the Main Street, Central
20	Avenue to Airport Road. That's in the Town of Eagar, and it's
21	actually a Town of Eagar project that we are managing, and it's
22	to installed solar lighting. This project is going to it's
23	scheduled to open on August 2nd, and it's programmed at
24	\$2.1 million.
25	And the Woolford Road project, which is in Show

1	Low, on Show Low's Woolford Road, it's from Whipple to State
2	Route 260, and this is a pavement rehabilitation project that
3	opened on June 28th at \$1.7 million is the (indiscernible).
4	And the last project is State Route 73 and 260
5	intersection at Hon-Dah. This is a safety project to install
6	lighting and sidewalks. The bid opening for that is scheduled
7	for August 9th, and it's programmed at \$2.1 million.
8	And that's really all I've got unless there's
9	questions.
10	CHAIRMAN SEARLE: All right. Any questions for
11	Mr. Wilson?
12	MR. MAXWELL: (Inaudible.)
13	CHAIRMAN SEARLE: Mr. Maxwell.
14	MR. MAXWELL: Thank you, Mr. Chair. I appreciate
15	it.
16	Mr. Wilson, I'm going to ask you a real basic
17	question, because I want to learn the definitions and
18	differences between some things. So a lot of times we use the
19	term "rehabilitation"
20	MR. WILSON: Uh-huh.
21	MR. MAXWELL: when we're talking on a
22	construction project versus pavement preservation or
23	reconstruction or construction. So can you give me the
24	definition of what the rehabilitation is, and is it more of a
25	project a construction project versus just pavement

1	preservation?
2	MR. WILSON: Yes. It's really it's a little
3	bit deeper amount of work that's designed to last longer. So
4	preservation is more of the surface work with the shorter
5	lifetime, whereas rehabilitation will be a little deeper
6	treatment that should get, you know, really more than ten years.
7	MR. MAXWELL: And am I correct to say that all
8	rehabilitation projects do come through the normal project
9	construction project process?
10	MR. WILSON: Pretty much. Pretty much.
11	MR. MAXWELL: Thank you. Appreciate the help.
12	CHAIRMAN SEARLE: Okay. Any other questions?
13	Mr. Meck, Ms. Howard, any questions for
14	Mr. Wilson?
15	MS. HOWARD: I'm a little curious about
16	seasonality here. Are you doing are we doing
17	reconstruction are we doing road projects throughout the
18	winter, and if not, is it what do you do in preparation for
19	the winter for some of the seasonality components?
20	MR. WILSON: Yeah. And, you know, that really
21	depends on the top of project that we're talking about, so, you
22	know and how much effort you want to put into it. So on a
23	lot of the if it's, like, a project that has a lot of dirt
24	work and things like that on it, then you can pretty well do a
25	lot of that during the wintertime and but if it's something

1	like these (indiscernible) surface treatments, we're pretty well
2	limited until June through August.
3	CHAIRMAN SEARLE: (Inaudible.)
4	MR. WILSON: And so it really is very dependent
5	on the work to be done on the project.
6	VICE CHAIR DANIELS: And is there a lot of
7	preparation that needs to be done for your winter as far as
8	winterizing, making sure we have you know, I would imagine
9	equipment ready. I drove past your facility on the way and saw
10	that it wasn't exactly designed the way some of the ones in the
11	Valley are, so
12	MR. WILSON: Well, that one's been there a long
13	time. It has. And yeah, you know, we really are always
14	thinking towards winter at these type of elevations. You know,
15	in the summertime, you know, our equipment services staff does a
16	lot of heavy work on these plow trucks, because they take such a
17	beating throughout the wintertime. And so we catch up on that
18	kind of maintenance. You know, we and we do a lot of
19	planning. We you know, we make sure all of our salt barns
20	are full, all the material's ready to go.
21	It is it is really a pretty well year round
22	process between, you know, planning and doing the preparation
23	work in the summertime and, you know, dealing with the snow in
24	the wintertime. And in this district, you know, we have some
25	pretty good elevation. Every you know, we're almost

29	
almost the entire district is almost over 5,000 feet. We're a	
little lower down at Salt River Canyon Bridge. There's a little	
low section that's just under 5,000 up (indiscernible), but most	
of it's all over 5,000 feet, but we also go up to 9,000 feet at	
Sunrise, and so we really do try and plan our maintenance	
activities and that to really focus on those areas whenever we	
can get there and we have a little more time working at lower	
areas, you know, like Holbrook or someplace like that.	

MR. MAXWELL: Thank you.

10 CHAIRMAN SEARLE: Ed, remind me. Where is your 11 district office at?

1 question --2 CHAIRMAN SEARLE: Okay MR. MAXWELL: -- for staff really on this one. 3 So a lot of the right-of-ways were to do with 4 SR-95. Is that part of the process? Because it looks to me 5 like we're -- it's not just the right-of-ways to the side of the 6 7 roads. We're giving the roads back to (indiscernible). Is part 8 of the process of moving the control and responsibility for 9 SR-95 to Lake Havasu City? 10 MR. BYRES: So, Mr. Chairman, Board Member 11 Maxwell, a lot of those are excess right-of-way that we're 12 taking and turning back -- turning over --13 MR. MAXWELL: Right. 14 MR. BYRES: -- to the municipalities. So we're 15 taking them out of our inventory, and instead of us having to 16 maintain them, we turn those over. 17 MR. MAXWELL: Understand. I guess my question's is it just the right-of-ways we use for construction on that 18 19 front or is it the entire roadway? Because I know there's an 20 effort to move SR-95 --21 MR. BYRES: If this particular --22 MR. MAXWELL: (Inaudible.) MR. BYRES: -- case, no. This is just the excess 23 right-of-way. 24 25 MR. MAXWELL: It's the right-of-way. That

1 answers the question. Thank you very much, Greg. I appreciate 2 it. MR. ELTERS: Mr. Chairman. 3 CHAIRMAN SEARLE: Mr. Elters. 4 5 MR. ELTERS: Just a minor clarification for Board 6 Member Maxwell. It's Bullhead City? I thought I heard you say 7 Lake Havasu. 8 MR. MAXWELL: I did. 9 MR. ELTERS: It is Bullhead City, and it -- if you look at the documents, it references the IGA from September 10 11 last year. So this is just basically a house clearing item, and 12 the city is supportive, ready for it and have all the 13 ingredients in place that carry forward with it. 14 MR. MAXWELL: Thank you. 15 CHAIRMAN SEARLE: All right. With that, if 16 there's no other comments or questions, I'm going to go ahead 17 and call for the vote, and since we do have two that are 18 remotely, I'm going to ask is there any opposition to the motion 19 in front of us? 20 MR. MECK: Jackie Meck. No opposition. 21 CHAIRMAN SEARLE: If there's no other opposition, 22 all those in favor say aye. 23 BOARD MEMBERS: Aye. 24 CHAIRMAN SEARLE: I believe the item passes 25 unanimously.

1	We'll now move to Item Number 4, which is our
2	financial report. And Mr. Roehrich, I believe you're going to
3	present that?
4	MR. ROEHRICH: So Mr. Chairman, Board Members,
5	with the current issues that we're having with internet
6	problems, Kristine Ward is working with the rest of the staff to
7	address those. It is affecting a number of areas within the
8	department. She asked if I could present the financial
9	reward financial report because I do such a poor job.
10	So here's our HURF revenues. We're pretty much
11	on track with what the estimate was. We're within the range for
12	variation. So we're I'm guessing she's going to say we're
13	pretty good.
14	Next slide.
15	Here's the actuals. We're collecting
16	\$183 million so far, so I know it's still kind of early in the
17	fiscal year, but we're like I said, we're on track.
18	Next slide.
19	Regional Area Road Fund, Maricopa County. Again,
20	we're within our range of variation.
21	Next slide.
22	You can see what we've collected so far this
23	year, \$62 million. \$62.9 million.
24	Next slide.
25	That ends the financial report.

1	CHAIRMAN SEARLE: Very good. I don't believe we
2	have any questions.
3	MR. ROEHRICH: Thank the Lord for that.
4	UNIDENTIFIED SPEAKER: (Inaudible) question.
5	CHAIRMAN SEARLE: And a thought did cross my mind
6	is on this financial report, a lot of times we get asked for a
7	lot of things on the Transportation Board, and, you know, we
8	really don't have any control over the income coming in.
9	It's our duty is actually the allocation of income that comes
10	in, and I think we'd all getting back to Mr. Gallegos'
11	comment in the call to the public this morning is there's
12	obviously not enough money to go around for all the projects
13	that needs to be done, and so but that's it does give
14	us you know, everybody an idea of what kind of funds we're
15	looking at, so
16	MR. ROEHRICH: And Mr. Chair and Board Members, I
17	know last month Board Member Maxwell talked about a future board
18	agenda to discuss some revenue options, what are states doing,
19	and that is something that Kristine's team is actually working
20	on. So we do want to present some information to, like, the
21	director and, you know, maybe Governor's staff and other people
22	when we talk in the future.
23	You know, the system we have will be the system
24	we're willing to pay for, and we've said that time and time
25	again, and we've obviously heard it from the director and from

-	
1	the state engineer and others, and as you said, there are states
2	out there who have found different ways to either produce
3	revenues, leverage the revenues they have, and so with Kristine,
4	I do know she's working on something, so Mr. Maxwell, we can
5	come obviously later this year, definitely before the next
6	legislative session, so we have something developed for that.
7	So it will be coming at a future date.
8	MR. MAXWELL: Mr. Chair.
9	CHAIRMAN SEARLE: Mr. Maxwell.
10	MR. MAXWELL: Thank you, Floyd. I appreciate
11	that, and I appreciate that Kristine's taking a hard look on it.
12	Echoing the Chair's comments about Mr. Gallegos'
13	comments, if any of that information becomes available, I think
14	it would be a great starting point at the Rural, not just for
15	conversation, but for the introduction of other options.
16	Everybody hears us talk about and say things like
17	we need to modernize the transportation and infrastructure
18	funding system, and everybody starts saying, oh, they're just
19	going to want to raise taxes, and that's not the case. A lot of
20	these ideas on how to get the funding is more creative, more
21	direct to those who are actually doing we'll call it the
22	damage of the wear on the roads, and it's there's a lot of
23	different options to do it.
24	What we do know now is the current system is not
25	providing us enough money to address even a significant portion

1	of the needs in this state and the farther we get behind, as we
2	see from the on some of the longer fiscal reports where we
3	see the side and I know Mr. Byres shows us all the time, the
4	status of the roads in our state. They're moving in the wrong
5	direction. So at some point I think it's a conversation we have
6	to have.
7	We won't be in charge of making the decision.
8	This is something that's going to take legislative initiative
9	and action as well. So any time we have an opportunity to talk
10	to the legislators about the different options, it would be
11	great. So if even if it's not prepared for Kristine to come
12	to us to give the presentation, I think there's great
13	interaction with the different MPOs and the folks working in
14	this arena to have some of that knowledge and information as we
15	learn more.
16	CHAIRMAN SEARLE: It's kind of getting off track
17	a little bit here, gentlemen, so let's
18	MR. MAXWELL: It was a quick financial report.
19	CHAIRMAN SEARLE: I know.
20	MR. MAXWELL: For a moment.
21	CHAIRMAN SEARLE: That's correct. So let's
22	let's get back on the agenda, and I believe go ahead.
23	MR. ELTERS: Thank you, Mr. Chairman. Just a
24	quick comment.
25	I acknowledging what you what we all heard.

1	I just want to point out and compliment the department, the
2	chief financial officer and our investors, because our
3	investment pools are doing really well in this economic
4	environment that we're in. Investing smartly can have a
5	significant return, and I look at our investment and believe
6	that they're doing really well.
7	So just a compliment to the department for doing
8	what they're doing. If you can't if you can't secure
9	additional revenues to meet the need, at least you invest smart
10	and you get some return that way. So it's looking really good.
11	CHAIRMAN SEARLE: Higher interest rates
12	definitely make that an easier job, so
13	All right. I will go ahead and close then for
14	the Item 4, move on to Item Number 5, which is our Multimodal
15	Planning Division report from Mr. Hossain. And I believe you're
16	going to be presenting the next three items?
17	MR. HOSSAIN: Four items.
18	CHAIRMAN SEARLE: Okay. Very good.
19	MR. HOSSAIN: Good morning, Mr. Chair and the
20	members of the Board. My name is Iqbal Hossain, Deputy Director
21	of the Multimodal Planning Division. Today, as I said, I will
22	present Items 5, 6, 7 and 8. I'll start with Item Number 5, the
23	Multimodal Planning Division report.
24	The first one is tribal transportation update.
25	Three updates on Safety Roundtable and Transportation Summit.

Г

1	The Arizona Tribal Transportation Safety Roundtable planned for
2	September 18 and 19 has been canceled, and the roundtable is
3	anticipated to be rescheduled in 2025.
4	The 2024 Arizona Rural Transportation Summit is
5	scheduled for October 16 and 18. ADOT's tribal outreach is now
6	focusing on the tribal component of the summit. A save the date
7	announcement and more information will be shared with the tribes
8	at the end of the month.
9	Next slide, please.
10	Three updates on ADOT tribal outreach. ADOT is
11	developing the Arizona Strategic Highway Safety Plan and
12	Alternative Transportation Safety Action Plan, and we hosted
13	workshops and public meetings involving local jurisdictions,
14	transportation safety experts and tribal nations. As part of
15	our tribal outreach, we invited tribal nations to comment and
16	participate in the Strategic Highway Safety Plan Tribal Lands
17	Focus Area Team.
18	Various tribes including Navajo Nation, Hopi
19	Tribe and Hualapai Tribe and others attended the workshop public
20	meetings and joined the emphasis area team. A few other
21	tribal-related entities like Indian Health Services and
22	Intertribal Council of Arizona also participated.
23	Next slide, please.
24	On July 1st, 2024, ADOT Traffic Safety Group,
25	ADOT Southcentral District and ADOT MPD attended a stakeholder

	50
1	meeting to develop the Tohono O'odham Nation 2024 Strategic
2	Transportation Safety plan update. The Nation's project team
3	will accept community input through July, with the first report
4	expected in August.
5	Some updates from north and southern Arizona
6	regions. A partnership meeting between ADOT (inaudible) and
7	Navajo Nation is scheduled for August 1st at the Navajo DOT
8	office complex in New Mexico. The topics covered will be
9	updates on current and upcoming ADOT projects, updates from ADOT
10	Aeronautics Group and crash data reports.
11	ADOT staff from the state engineer's office
12	Northeast District and Environmental Planning Group will meet
13	with officials and representatives from the Pueblo and the Zuni
14	in August 2nd in New Mexico.
15	Another meeting between ADOT and San Carlos
16	Apache Tribe transportation is scheduled for August 15.
17	Finally, a national event, the 2024 National
18	Transportation in Indian Country Conference will be held in
19	Oklahoma from August 25th through August 29th.
20	This concludes my presentation on tribal updates.
21	I'll be happy to answer any question you may have.
22	CHAIRMAN SEARLE: Any questions for Iqbal at this
23	time? Very good. Move on.
24	MR. HOSSAIN: Thank you. Then I'll move on to AZ
25	SMART statutory and policy update.

1	Mr. Chair and the members of the Board, you may
2	remember from the April meeting that House Bill 2318 made
3	significant changes to the AZ SMART program. This month I'll be
4	providing you with an in-depth review of the changes, the
5	implications of the changes, and how we are proposing to address
6	them. Our goal is to share the new version of the draft program
7	with you in August for your review.
8	CHAIRMAN SEARLE: Is this still under Item 5?
9	MR. HOSSAIN: Yes.
10	CHAIRMAN SEARLE: Okay.
11	MR. ROEHRICH: Mr. Chairman, I did notice that on
12	the agenda, we prepared you the Chairman's agenda, we did not
13	update that to reflect what the agenda was up posted to the
14	public.
15	CHAIRMAN SEARLE: Okay.
16	MR. ROEHRICH: So this is a proper item. He's
17	not going rogue.
18	MR. HOSSAIN: All right.
19	CHAIRMAN SEARLE: Just making sure.
20	MR. HOSSAIN: All right. So there's six major
21	updates on the changes on the program. Change number one, the
22	Legislature opened the AZ SMART program up to any applicant
23	eligible to apply for a federal discretionary grant. We believe
24	this will significantly increase the demand of the program and
25	we'll see a wider variety of projects than in the past.

1	I'll give a little background on this. Even
2	though we have defined surface transportation to be road,
3	bridge, transit or rail, rail and transit projects have not been
4	able to participate because the funding can go only to cities,
5	towns and counties. As a result, the transit projects, for
6	example, did not qualify in the past, but now they do.
7	Our proposed approach on this, we are
8	double-upping some criteria for the Board's consideration to
9	facilitate a data driven comparison of projects. It will apply
10	to all projects, and it will include current criteria such as
11	looking at the amount that the (inaudible) is contributing,
12	factors such as population, system condition, status of the
13	project in TIP, et cetera. The priority criteria will be part
14	of the application package and transparent to all parties.
15	Change number two. The Board now has the
16	authority to determine an applicant's technical and financial
17	capacity to deliver the proposed project. This applies to
18	existing and the new applicants such as COGs and MPOs, regional
19	transition, transit entities and non-profit organizations.
20	A little bit of background of this. The current
21	applicant pool of cities, towns and counties are well
22	established and transparent entities. The public has access to
23	their annual financial statements, even online. They generally
24	are already in the State accounting system. They have worked
25	with ADOT before, and they are familiar with the reimbursement

1 measure of the plans.

2	With the addition of the new applicant types, the
3	Board will need additional information to determine the
4	technical and the financial capacity of the applicants. Due to
5	this, our proposed approach is we propose requesting financials,
6	technical and other (indiscernible) information from the
7	applicant. For example, two years' worth of financial
8	statements, bank statements, board resolution demonstrating the
9	commitment to the projects, and IRS determination letters, et
10	cetera. These items will provide these items should provide
11	data for staff to use in financial (indiscernible) to assist the
12	Board in making the technical and financial determinations.
13	CHAIRMAN SEARLE: Mr. Maxwell.
14	MR. MAXWELL: Thank you, Mr. Chair. Quick
15	question. Under the new applicants, you include non- and
16	for-profits. I mean, that would tell me it could be everybody.
17	So I'm I mean anybody, any entity. So what is what are
18	the non- and for-profits you're trying to get to in that
19	CHAIRMAN SEARLE: I do know that some of the MPOs
20	are non-profits.
20 21	are non-profits. MR. MAXWELL: No, I understand that, but I so
21	MR. MAXWELL: No, I understand that, but I so
21 22	MR. MAXWELL: No, I understand that, but I so that's my question. Is the non- and the for-profits

l l	
1	they have to be eligible to file for the federal grant.
2	MR. HOSSAIN: Mr. Chairman and Board Member
3	Maxwell, those organizations, they are who are eligible to
4	receive federal grant. They are the one who
5	MR. MAXWELL: So they can be a for-profit or a
6	non-profit.
7	MR. HOSSAIN: (Inaudible.)
8	MR. MAXWELL: If they're eligible to apply for a
9	federal grant, they're good to go then. Okay. Thank you.
10	MR. HOSSAIN: So on this, we're currently working
11	with our auditors to identify the applicable documents that
12	we'll be requesting. This information and the scoring will be
13	the part of the application package and transparent to all
14	parties.
15	Change number three. Applicants awarded AZ SMART
16	Fund for design and other engineering services will now be
17	required to apply for the federal grant within two years after
18	the award. Otherwise, the award ultimately lapses.
19	So to give you some background on this, out of
20	the 46 applications received to date, over half of them have
21	been for design and other engineering services. Project design
22	generally takes 12 to 18 months under the current process once
23	the Board awards the design and other engineering services.
24	Before design can even begin, the project needs to be added to
25	the TIP, and IGA is double-upped and approved by the council,

1	ADOT, the applicant, their attorney and the AG's office. These
2	activities generally takes several months. ADOT aims to shorten
3	this time it takes to initiate the design work after the Board
4	award. This will help the applicants make the two-year
5	deadline.
6	Our approach to this is we'll be proposing a new
7	approach called the request for project grant applications. The
8	goal is to have all the administrative work done before the AZ
9	SMART application is submitted.
10	VICE CHAIR DANIELS: Sorry. Question on that.
11	MR. HOSSAIN: Sure.
12	VICE CHAIR DANIELS: Is that feasible for some of
13	our smaller rural areas that are applying? I what I
14	sometimes I think what we do is in an effort to streamline the
15	ADOT process, we put up a barrier for the municipality or the
16	county or whomever it is. So is this a feasible approach for
17	them? I know we're trying to shorten our timeline, but is this
18	really something that they're going to be able to are we
19	creating a inadvertently creating a barrier in that process?
20	Oh, look. You have a helper. (Inaudible.)
21	UNIDENTIFIED SPEAKER: (Inaudible.)
22	MR. HOSSAIN: Yes, please.
23	MS. DANKA: Mr. Chair, Board Members, we are
24	talking to stakeholders now.
25	VICE CHAIR DANIELS: Okay.

1	MS. DANKA: And in the process we're envisioning,
2	it is used in other programs throughout the state. It's what
3	I'm finding is it's not a new thing for many of them, and
4	they're still in control. They'll be able we won't make any
5	changes regarding having specific rounds. The applications will
6	be continuously open, and the things we would put on the front
7	end is going to council, getting a resolution, and submitting it
8	with the application. And the we changed the wording in the
9	statute. It used to call for an intergovernmental agreement.
10	They deleted intergovernmental. So we're able to do it as more
11	of a procurement approach where all of the administrative stuff
12	is done up front.
13	VICE CHAIR DANIELS: Okay.
14	MS. DANKA: And as I'm talking to you, I've had a
15	conversation with the public works director for Pinetop this
16	morning, and he was familiar with the process. He says we've
17	done it before. We are talking with COGs and MPOs. You know,
18	we're trying to do some stakeholder work around designing the
19	program.
20	VICE CHAIR DANIELS: Okay. Thank you. That's
21	helpful.
22	MR. ROEHRICH: And that comment was made by
23	Ms. Lisa Danka from our Planning Division. Please if you're
24	going to speak, please introduce yourself so we have on it the
25	record. Thank you.

	-
1	MS. DANIELS: I feel like we know you, so
2	we're
3	MS. DANKA: I know. I'm
4	MR. ROEHRICH: But the people who hear it don't
5	know that.
6	MR. HOSSAIN: Next slide.
7	So now I'll move on to change number four. The
8	Board can now direct ADOT to close applications for a category
9	which has reached a minimum balance. To give you a little
10	background on this, we have seen very uneven application
11	activity across the city and county categories. As an example,
12	while the municipalities over 10K (indiscernible) was drawn down
13	quickly, the counties over 100K was not. So in this and it
14	is unknown at this point when the Legislature will make other
15	applications to the fund. Until then, the only revenue
16	program the program has is interest earnings, and we want to
17	sustain the program for as long as possible.
18	Due to this situation, our proposed approach is
19	staff will propose a minimum fund balance for each category.
20	Once a category falls below that minimum balance, the Board will
21	direct ADOT to close applications until the fund reaches a
22	certain threshold to resume accepting the applications.
23	Change number five, the Legislature requires the
24	Board to reject an award if an applicant receives funding from
25	another source of the same project. To give you some background

1	on this, we observed that applicants often seek funding from
2	various sources like federal earmarks, legislative appropriation
3	and AZ SMART funded projects. However, if they receive multiple
4	awards, it can make the project being overfunded. To mitigate
5	this, our proposed approach is we'll be proposing guidelines for
6	projects that receive access funding. For example, the project
7	scope awarded by the Board may not be expanded or enhanced or
8	other changes made in the attempt to keep the access AZ SMART
9	funding.
10	CHAIRMAN SEARLE: Mr. Hossain, just not getting
11	too technical, but it said board must rescind. Could that be a
12	may rescind?
13	MR. ROEHRICH: Lisa, if you're going to please
14	come up so we've got it on record.
15	CHAIRMAN SEARLE: Yeah.
16	MS. DANKA: Mr. Chairman, Members, Lisa Danka
17	with the Multimodal Planning Division.
18	MR. ROEHRICH: Thank you.
19	MS. DANKA: I believe the statute is very clear
20	that the Board must rescind.
21	CHAIRMAN SEARLE: Okay. Thank you.
22	VICE CHAIR DANIELS: So to clarify that maybe
23	even a little bit further, sometimes it takes multiple funding
24	sources in order for some of our smaller communities to be able
25	to afford to actually even implement it. We've had a couple

1	situations, I think, in the past where they've been awarded but
2	weren't able to secure the additional funding that they needed
3	whether that be bond or whatever else it is. So are we being
4	really specific about when they can combine funding sources?
5	Are there is it just other types of state funding? Like,
6	what does the statute actually say?
7	MS. DANKA: I'll have to pull the statute to
8	confirm that.
9	VICE CHAIR DANIELS: (inaudible) quoting. Sorry.
10	MS. DANKA: Yes. But we are we are talking
11	about a situation in which they get a SMART award from us, and
12	we've actually had this happen once during AZ SMART, and they
13	also get for the exact same project they get an additional
14	award from somebody else, and now that project was double
15	funded. So under that scenario, they got the funding from the
16	Legislature. You know, you can't double dip, and so they had to
17	choose to either give up the legislative appropriation or the AZ
18	SMART funding, and they chose to release the AZ SMART funds.
19	That required us to come to you and ask for recension of that
20	Board resolution. And so yeah, they're cobbling it together
21	from everywhere. We know that we're not trying to we're not
22	trying to preclude that or discourage it, you know. We want
23	them to get as much money as they need. We just don't want them
24	to be overfunded.
25	VICE CHAIR DANIELS: Okay. So as long as they

1	don't reach 100 percent of their need let's say they have a
2	construction project, it's a \$10 million price tag, they get,
3	you know, 1 million from I'm just throwing numbers
4	1 million from AZ SMART, and then they are able to secure
5	9 million through their legislature. They're fine. We don't
6	have to rescind anything. It's just if they got 11 million
7	from okay.
8	MS. DANKA: Yeah.
9	VICE CHAIR DANIELS: So that isn't totally clear
10	in this. If they're applying it for the same project I just
11	wanted to make sure we're being really, really explicit as
12	long as you don't exceed your total construction budget
13	MS. DANKA: Correct.
14	VICE CHAIR DANIELS: for that particular
15	project.
16	MS. DANKA: That's a good observation. We'll
17	make that very clear
18	VICE CHAIR DANIELS: Okay.
19	MS. DANKA: in the call for projects packet.
20	VICE CHAIR DANIELS: So by all means, assemble
21	dollars however you need to.
22	MS. DANKA: Yes.
23	VICE CHAIR DANIELS: Don't exceed your budgeted
24	(indiscernible)
25	MS. DANKA: Correct.

1	VICE CHAIR DANIELS: amount. Got it.
2	MS. DANKA: Correct.
3	VICE CHAIR DANIELS: Okay. I misunderstood.
4	Thank you.
5	UNIDENTIFIED SPEAKER: Maybe you should stay.
6	(Inaudible conversation.)
7	UNIDENTIFIED SPEAKER: All right.
8	MR. HOSSAIN: Finally change number six, one of
9	the biggest board authorities in the bill is to redistribute
10	unawarded funds across the categories. The redistribution will
11	take place in January and July of each year. The first
12	redistribution would happen in January 2025. We'll bring a
13	proposal to the Board on this topic as we get closer.
14	Next slide, please.
15	So the bill will be effective on September 14th,
16	2024. There are some significant changes involved, but the
17	stakeholders are anxious for the new program. So we are
18	proposing an aggressive schedule. This will be August board,
19	review of revised board policy and AZ SMART application
20	materials. September board, the final approval. October 1st,
21	the new program effective. In January board, the first funding
22	redistribution.
23	Because of the significant changes between July
24	and September, between July and September board meetings, we'll
25	be working with stakeholders to review the revised program and

1	finalize that draft program.
2	CHAIRMAN SEARLE: Great. Any other questions on
3	that? Very good.
4	MR. HOSSAIN: Yeah. Thank you.
5	Mr. Chair and the members of the Board, then I'll
6	move on to Item Number 6, the airport guideline policy updates.
7	Go back. Thank you.
8	So again, now I'll present Item Number 6, Airport
9	Development Policy updates to the Board for discussion and
10	possible action. I would like to start with a brief background
11	on this policy update.
12	In January and May of this year, we briefed you
13	about the update to the airport development policy guideline.
14	The purpose of these policy changes or updates are, number one,
15	from our previous experience, we observed that the smaller
16	airports face challenges in upcoming to coming up with their
17	matches currently, which is 10 percent.
18	Number 2, it will lower the max requirement for
19	general aviation basic airports from the (inaudible) Airport
20	Pavement Management System program from 10 percent to 5 percent.
21	And number 3, this will create more opportunity
22	for the general aviation basic airports to preserve their
23	airport pavement and be successful in meeting or exceeding the
24	growing needs of the public.
25	In a nutshell, the proposed update to the Board

1	Policy Chapter 39, Part 1, Section C, for the Airport Pavement
2	Management System is that is that all airport categories will
3	receive a 90 percent state match except the general aviation
4	basic category to receive a 95 percent statement.
5	ADOT is requesting Board Policy Chapter 39,
6	Part 1, Section C for the Airport Pavement Management System
7	Program be updated to add a sentence for the State match
8	percentage. And the sentence is highlighted right in the slide.
9	It reads: The Board may fund an eligible project's costs up to
10	a maximum of 90 percent of eligible costs at Commercial Service,
11	Reliever, General Aviation Community, General Aviation Rural
12	Airports and 95 percent at general aviation basic airports.
13	CHAIRMAN SEARLE: And this is the only change
14	that's being proposed?
15	MR. HOSSAIN: Correct.
16	CHAIRMAN SEARLE: Okay. And are you you would
17	need a motion for this approval?
18	MR. HOSSAIN: Yes. Thanks.
19	CHAIRMAN SEARLE: All right. Before I ask for
20	the motion, are there any questions on this particular policy
21	change? Ms. Howard, Mr. Meck, any questions?
22	MS. HOWARD: None here.
23	MR. MECK: A question.
24	UNIDENTIFIED SPEAKER: Maxwell confirmation
25	when it comes to airport (indiscernible) good.

1	UNIDENTIFIED SPEAKER: It's good.
2	CHAIRMAN SEARLE: All right. If there's no other
3	questions, I'd entertain a motion.
4	MR. MAXWELL: Mr. Chair, I'll move that to
5	make the change allowing the Board to fund eligible projects
6	cost for 90 percent for the commercial service relievers,
7	general aviation and GA community and GA rural airports and the
8	95 percent at general aviation basic airports.
9	CHAIRMAN SEARLE: All right. I have a motion.
10	Do I have a second?
11	MR. ELTERS: Second.
12	MR. MECK: Jackie Meck. Second.
13	CHAIRMAN SEARLE: All right. Mr. Elters, is it
14	all right I'm going to give Mr. Meck the second?
15	MR. ELTERS: Certainly.
16	CHAIRMAN SEARLE: All right. So with that, I
17	have a motion and a second. Is there any other questions or
18	discussion before I call for the vote? Seeing none. Once again
19	because we have two remote participants, is there any opposition
20	to the motion?
21	MS. HOWARD: None here.
22	MR. MECK: No.
23	CHAIRMAN SEARLE: All right. Hearing no
24	opposition, all those in favor say aye.
25	BOARD MEMBERS: Aye.

1	CHAIRMAN SEARLE: Chair votes aye. Motion is
2	approved unanimously.
3	All right. Now we'll move to Item Number 7.
4	Again Mr. Hossain.
5	MR. HOSSAIN: Thank you, Mr. Chair and members of
6	the Board. And I'll move on to Item Number 7, Priority Planning
7	Advisory Committee, PPAC. Now I'll present Item Number 7,
8	Priority Planning Advisory to the Board for discussion and
9	possible action.
10	CHAIRMAN SEARLE: Mr. Hossain, just most of
11	these items are just moving the items from '24 into '25; is that
12	correct?
13	MR. HOSSAIN: There are some yes. Correct.
14	CHAIRMAN SEARLE: Okay.
15	MR. HOSSAIN: There's modifications. Yes. Most
16	of them are '24 to '25. Yes.
17	CHAIRMAN SEARLE: Okay.
18	MR. HOSSAIN: Mr. Chair and the members of the
19	Board, for your consideration I would like to present the
20	proposed changes to the FY '25 through FY 2029 for the State
21	Transportation Facilities Construction Program, Items 7A through
22	7N as project modifications.
23	CHAIRMAN SEARLE: All right. Very good. Before
24	I call for the motion, are there any questions or concerns on
25	the items being proposed? Mr. Meck, Ms. Howard, any comments or

questions? 1 2 MS. HOWARD: No. MR. MECK: Jackie Meck. 3 No. CHAIRMAN SEARLE: Very good. I would entertain a 4 5 motion then to approve PPAC project modifications and new projects Items 7A through 7N as presented. 6 7 MS. HOWARD: So moved. CHAIRMAN SEARLE: I have a motion by Ms. Howard. 8 A second? 9 10 VICE CHAIR DANIELS: Second. 11 CHAIRMAN SEARLE: By Ms. Daniels. Very good. 12 Before I call for the vote, is there any other questions or 13 discussion? Hearing none, is there any opposition to the motion in front of us? 14 15 MS. HOWARD: No. 16 MR. MECK: No. 17 CHAIRMAN SEARLE: Hearing no opposition -- I'm 18 assuming, Ms. Howard, that's -- that you don't have any 19 That's -opposition. 20 MS. HOWARD: Yes, Chair. That is correct. 21 CHAIRMAN SEARLE: Okay. Hearing no opposition, 22 all those in favor say aye. 23 BOARD MEMBERS: Aye. 24 CHAIRMAN SEARLE: Chair votes aye. Item passes 25 unanimously.

1	Now moving on Item Number 8, which is the Arizona
2	State March State Match Arizona SMART Fund program.
3	Mr. Hossain again.
4	MR. HOSSAIN: Thank you, Mr. Chair and the
5	members of the Board. Again, I will move on to Item Number 8,
6	AZ SMART Fund Program to the Board for discussion and possible
7	action.
8	Today we have one AZ SMART application on the
9	agenda, and the full application is included in the agenda
10	packet.
11	CHAIRMAN SEARLE: And this is for ADOT.
12	MR. HOSSAIN: Correct.
13	CHAIRMAN SEARLE: Any questions on the Arizona
14	SMART grant application request? Seeing none, I would entertain
15	a motion.
16	VICE CHAIR DANIELS: So moved.
17	MR. MECK: Jackie Meck. So moved.
18	VICE CHAIR DANIELS: Second.
19	CHAIRMAN SEARLE: All right. I have a motion by
20	Mr. Meck and a second by Ms. Daniels.
21	MR. MAXWELL: Mr. Chair, I do have one question.
22	CHAIRMAN SEARLE: Mr. Maxwell.
23	MR. MAXWELL: I apologize for not speaking up the
24	first time. So normally we get to see a slide that shows the
25	status of all funds. Is that further in your slide deck?

1	MR. HOSSAIN: Yes, I do have
2	MR. MAXWELL: Can we see that first, please?
3	MR. HOSSAIN: Sure, sure. Would have been next.
4	Next.
5	MR. MAXWELL: That's what I was looking for.
6	Thank you.
7	MR. HOSSAIN: Yeah.
8	MR. MAXWELL: Thank you, Mr. Chair.
9	MR. HOSSAIN: So do you want me to present this
10	slide as well?
11	CHAIRMAN SEARLE: So with this, there's still
12	plenty of there's still over 5 million available, yes. Okay.
13	MR. ROEHRICH: (Inaudible)
14	CHAIRMAN SEARLE: Very good. Very good. I do
15	have a motion and a second. Just remembered I was trying to
16	remember where I was at.
17	VICE CHAIR DANIELS: (Inaudible.)
18	CHAIRMAN SEARLE: Thank you, Jenn. I appreciate
19	that. Need all the help I can get to get through this.
20	All right. Any other questions or comments on
21	the motion in front of us before I call for the vote? Seeing
22	none.
23	Is there any opposition to the motion? Seeing or
24	hearing no opposition.
25	All those in favor say aye.

1	BOARD MEMBERS: Aye.
2	CHAIRMAN SEARLE: Chair votes aye. Item passes
3	unanimously.
4	MR. MAXWELL: Mr. Chair, if I could, one question
5	before we move on to the next item.
6	CHAIRMAN SEARLE: Yes, sir.
7	MR. MAXWELL: So the Legislature legislative
8	changes to the AZ SMART Fund I'm sorry if I missed it when I
9	stepped out. Those will take effect 90 days from sine die. So
10	will we have the changes to this chart, to the categories and
11	all that in front of us before that date.
12	MR. HOSSAIN: It will be effective on
13	September 14th, 2024.
14	MR. MAXWELL: Right. And so will we
15	MR. ROEHRICH: So, Mr. Chairman, Mr. Maxwell, I
16	think Iqbal, you had mentioned you're coming back in August
17	with the actual changes.
18	MR. HOSSAIN: Exactly.
19	MR. ROEHRICH: This was just to give you what
20	we've got, you know, since there was a change. Staff is working
21	it. We're going to bring back the full list of the guidelines
22	to the application, to the policy. We'll come back in August
23	for a final board review and approval.
24	CHAIRMAN SEARLE: You stepped out when this was
25	all presented, Mr. Maxwell, so I think

1	MR. MAXWELL: I was afraid of that.
2	CHAIRMAN SEARLE: Yes.
3	VICE CHAIR DANIELS: The last part of your slide,
4	though, (inaudible) say that we'd be coming back in January for
5	the redistribution component.
6	MR. MAXWELL: Correct.
7	CHAIRMAN SEARLE: That the schedule is for
8	January for the redistribution.
9	VICE CHAIR DANIELS: So we're just in August
10	we're going to be looking at the new rules and
11	CHAIRMAN SEARLE: The policy.
12	VICE CHAIR DANIELS: making sure we have the
13	policy in place, and then January will be the redistribution of
14	the funding.
15	MR. HOSSAIN: Yes.
16	MR. MAXWELL: So I kind of do have a follow-up,
17	which may not have been asked during that time. Did the
18	legislation say that the new categories were not eligible to
19	provide for January? So if we don't redistribute the funds
20	until then, how will we be able to issue anything to the new
21	those new folks eligible
22	CHAIRMAN SEARLE: That will be in October.
23	UNIDENTIFIED SPEAKER: December.
24	CHAIRMAN SEARLE: They'll be eligible in October
25	if I we will approve the policy in September, which

1	MR. MAXWELL: I think this question's still the
2	same, though. If we don't have the redistribution until
3	January, that's going to show where all the money's going to
4	lie, and how will we know those new categories or will those
5	categories already be funded in October.
6	MS. DANKA: Mr. Chairman, Members, nothing about
7	the categories will change with the new program. They'll still
8	be ADOT's category, munis (phonetic) over 10, munis under 10,
9	counties over 100K, counties under 100K. So this won't change
10	until January.
11	CHAIRMAN SEARLE: Okay.
12	MS. DANKA: The legislation gave you the ability
13	to redistribute beginning in January.
14	CHAIRMAN SEARLE: Understand.
15	MS. DANKA: So we're appearing starting to accept
16	applications in October under the new redesign. This document's
17	still going to look like this. In January, when we bring you
18	the proposed guidelines for redistribution in the fall, once you
19	approve those in January, we will sum the amount remaining in
20	every category, we'll divide it by five, and we'll replenish
21	each pot at that time.
22	MR. MAXWELL: So a follow-up question, Mr. Chair,
23	if I could. I know you're giving me that look going, come on,
24	this was going to be one of the fastest meetings ever.
25	So when a COG or an MPO or a tribe applies

1	MS. DANKA: What categories do they fall in?
2	MR. MAXWELL: Yes.
3	MS. DANKA: Mr. Chairman, Members, we are working
4	on that, and the we will bring you a proposal when we
5	bring you the whole shooting match, it will be identified in
6	there. It's now based on where the project is located, not who
7	the applicant is.
8	MR. MAXWELL: I understand. I'm jut concerned
9	for that period where the all of a sudden comes October 1st,
10	the COGs are eligible to apply, and if they're if we're going
11	to see an uptick, I think between that and potentially the
12	tribes where that's where we're going to see it, because
13	you've got organizations that work on identifying funding to
14	spend. So I think I just want to make sure we're not going
15	to find ourselves in a position where we're going to have
16	applications from the COGs in November and we don't have either
17	a redistribution or the policy in place. So thank you for
18	the
19	MS. DANKA: (Indiscernible)
20	MR. MAXWELL: Yes.
21	MS. DANKA: and you can redistribute for the
22	first time in January. It's January and July, if you choose to
23	do so. It's permissive.
24	MR. MAXWELL: Thank you.
25	VICE CHAIR DANIELS: So since the since we're

1	going to see the policy in August, when they apply in October,
2	they'll know. They just won't know the total funding amount
3	that's in there until January. It doesn't really change their
4	application, because they're not going to be taking the whole
5	funding amount.
6	CHAIRMAN SEARLE: Well, actually, we do know what
7	the funding amount is for the different
8	VICE CHAIR DANIELS: No, no. That's what I'm
9	saying is if there's a redistribution of the in each pot
10	would, right, which is what we're looking at.
11	MR. MAXWELL: I just see Mr. Gallegos smiling
12	back there on all this opportunity, so I just Yeah. I
13	apologize for stepping out, Mr. Chair.
14	CHAIRMAN SEARLE: All right. I will we will
15	hold you feet to the fire, Mr. Maxwell. All right.
16	VICE CHAIR DANIELS: All good.
17	CHAIRMAN SEARLE: So I we just approved the
18	you took me off a you got me sidetracked here. I think we're
19	done with Item 8. We voted.
20	MR. ROEHRICH: Yes, sir. You're ready to move on
21	to Item Number 9.
22	CHAIRMAN SEARLE: Thank you for keeping track,
23	Mr. Roehrich.
24	We'll now move to Item Number 9. Mr. Hossain,
25	you're thank you for your presentations, and we'll turn the

1 podium over to Mr. Byres. 2 MR. HOSSAIN: Thank you. MR. BYRES: Thank you, Mr. Chairman. 3 Item 9, state engineer's report. 4 To date we have 98 projects under construction 5 worth \$2.2 billion. 28 projects have been finalized in June, 6 worth 59.4 million. Fiscal year to date, we have had 91 7 projects finalized. That's a pretty substantial number for this 8 9 past fiscal year. 10 So I'm going to kind of go through all the different districts and the projects we have ongoing. 11 12 Next slide, please. So we'll start off with the Southcentral 13 14 District. We've got -- we've got five projects that we're 15 looking at. SR-87, Skousen traffic signal. That is occurring 16 in Page. That's getting kicked off on July 22nd. That's a very 17 significant intersection that is in desperate need of a signal. 18 I-10 widening at Ina and Ruthrauff is still 19 ongoing. They're at about 55 percent complete on that project. I-10, Country Club to Kino design. That's a 20 21 design-build project. We had that opening in June. So final 22 selections are still ongoing for the procurement on that 23 project. I-19 and Irvington TI, the final design is being 24 25 conducted. It's anticipated to go to construction in 2025.

1	And then SR-90, Border Patrol Station to Moson
2	Road. That project is about 15 percent complete to date.
3	CHAIRMAN SEARLE: Mr. Byres, on the Country Club
4	to Kino, is there the possibility that we're going to have two
5	projects going on on I-10 at the same time, or are they going to
6	be able to be able to work this where they're not both at the
7	same time?
8	MR. BYRES: We should be finishing up the
9	widening between Ina and Ruthrauff. We're hoping it is that
10	project is behind schedule at this point in time, but we're
11	hoping to have it completed and opened before any actual
12	construction starts on the Kino and Country Club.
13	CHAIRMAN SEARLE: That would be good.
14	MR. MAXWELL: So let me ask a follow-up to that
15	question, Mr. Chair, if I could.
16	CHAIRMAN SEARLE: Yes.
17	MR. MAXWELL: So is the plan if the one's not
18	done to delay the other one?
19	MR. BYRES: More than likely we're going to have
20	to, because as we it's just going to be they'll conflict
21	with each other.
22	MR. MAXWELL: Oh, I fully agree. Yeah.
23	MR. BYRES: So
24	MR. MAXWELL: Those are significant projects, and
25	for the people that use

1	MR. BYRES: Oh, yes.
2	MR. MAXWELL: that (indiscernible) that kind
3	of disruption in two spots would be problematic.
4	MR. BYRES: Yes, it will.
5	MR. MAXWELL: Especially that close together.
6	MR. BYRES: Especially for commerce coming
7	through on I-10.
8	MR. MAXWELL: Exactly. All right.
9	CHAIRMAN SEARLE: Thank you. Continue.
10	MR. BYRES: No problem.
11	Next slide, please.
12	Next is this is Northcentral District. We got
13	three different projects. US-89 and North Lake Powell Boulevard
14	roundabout. That project is getting ready to kick off. As a
15	matter of fact, the bid opening is today.
16	B-40 pavement preservation, project in Flagstaff.
17	The project is under development. It's looking at going to
18	construction in 2028.
19	And then the JW Powell Boulevard TI bridge
20	replacement. Project is about 50 percent complete. They're
21	getting ready to pour the second half of the deck coming this
22	July on in July.
23	Next slide.
24	Southwest District. We have the US-60 Vicksburg
25	to Junction, with SR-72. This is a pavement pres. project

1	that's currently under construction. It's about 33 percent
2	complete.
3	The I-10, Scaddan Wash to Plomosa. It too is a
4	pavement preservation project that's currently under
5	construction, at about 15 percent complete.
6	US-95, Aberdeen Castle to Castle Dome Mine Road.
7	Currently under construction at 25 percent complete.
8	And then the US-95, Rifle Range Road to Wellton
9	Mohawk Canal Bridge. That's about 95 percent complete.
10	Next slide.
11	Southeast District, current projects we have,
12	Waterfall Canyon Bridge. It's a bridge replacement project.
13	That's just kind of getting kicked off. It's at 1 percent
14	complete. It is going in conjunction with the Queen Creek
15	Bridge. The two are within about two miles of each other, so as
16	we have closures on Queen Creek Bridge, we'll take and utilize
17	those to do the the Waterfall Canyon Bridge at the same time.
18	So that's a much smaller bridge, but it will take a has a
19	major impact, because we have to close 60 through that section.
20	CHAIRMAN SEARLE: Two different contractors or
21	one contractor?
22	MR. BYRES: One contractor. We did we bid
23	them both together, but they're separate projects.
24	The next project we have is US-191 at SR-75 and
25	SR-78. The project is a roundabout project that's about 2

1	percent complete as of to date.
2	And then US-91 (sic) TI, the permanent bridge
3	repair. Right now we're waiting for (indiscernible) on the
4	bridge deck itself. Once we get that, then we'll actually get
5	going on the brick barrier. So that will get completed.
6	Next slide.
7	This is the Northwest District. We've got a
8	pavement preservation project, Needle Mountain TI to Lake Havasu
9	TI. It's has reconstruction, partial spots as well as
10	pavement preservation and a deck rehab that is ongoing, about 3
11	percent complete.
12	The West Kingman TI, which is I-40 and US-93, is
13	about 3 percent complete.
14	And then the Centennial Wash Bridge, which is
15	under construction, and is about 6 percent complete.
16	Next slide. And Ed already did Northeast, so
17	next slide.
18	So Central District, we have I-17, milling
19	project is complete. Bridge deck joint replacement has begun.
20	This one is had anybody that's driven through there, we've
21	had multiple weekend closures. We will be having some
22	additional weekend closures starting not this weekend, but for
23	the next two weekends after. So it's the same thing. We're
24	going to be working on the bridge deck joints trying to get
25	those done. We're doing as much as we possibly can in any given

1	section. So we'll be closing southbound one weekend and then
2	northbound the following weekend.
3	So next project we have is SR-101. That project
4	is going fairly well. We've got we're at about 23 percent
5	complete on that project.
6	The 101 Agua Fria bids have been open, and we
7	anticipate award actually starting today, with the construction
8	starting coming up this fall.
9	SR-303 to US-60 TI, the project's been awarded.
10	Preconstruction and partnering workshops are being held.
11	SR-202 preconstruction and partnering workshops
12	are being held, and we're looking at construction beginning in
13	August.
14	And then the US-60 median work is about 60
15	percent complete. That's US-60X.
16	And then the I-10 Gila River Bridge, phase one,
17	the drill shafts are complete. Most of the equipment is moved
18	back out from between the existing two bridges. So they're
19	getting ready to start on the pier work.
20	CHAIRMAN SEARLE: Mr. Byres, you might want to
21	update the Board on the emergency repair that you had two weeks
22	ago on that same area.
23	MR. BYRES: So we had a hole develop in the
24	westbound bridge of the existing bridge. We took and did a
25	temporary repair on that. The bridge was closed for about four

1 hours while we assessed what was happening with it. It was 2 isolated into the number two lane. We took and put a plate over it to start with so we could release traffic. We got traffic 3 released. That evening at ten o'clock, we closed the bridge 4 5 back down. We jacked out all of the concrete that was bad, 6 replaced it with early high strength concrete and reopened that 7 bridge at 6 o'clock the next morning, so... 8 CHAIRMAN SEARLE: Very --9 MR. MAXWELL: Mr. Chair, I've got one question on 10 this slide as well. 11 Believe it or not, Pima County, the number one 12 question I've gotten for the last several months has been the 13 I-17 closures, because there was such an effort through the 14 July 4th weekend and through other weekends to make sure there 15 were no closures for the traffic. So what is the best 16 explanation? I can make an assumption and guess, but what is 17 the best explanation for why we cannot keep those open on the 18 weekends? 19 MR. BYRES: So why we had done it before was 20 because in doing the milling operations, we have so much going 21 on, they had multiple mills going, so they have to do multiple 22 lanes, along with the truck traffic that's coming through. It 23 would make for an extremely dangerous situation to have that occurring and have live traffic. So that's why we didn't do it 24 25 in the past.

1	Now, with the two that are coming up, we're
2	replacing the bridge deck joints, which go across the entire
3	roadway. So we have to close the entire roadway in order to
4	replace that joint, and we can't do it in pieces. Those bridge
5	joints go the entire length.
6	MR. MAXWELL: Okay. Thank you. That will help
7	in the answers to the questions.
8	MR. BYRES: Next slide.
9	So we'll go on to Item 10. This is new
10	construction contracts.
11	CHAIRMAN SEARLE: Mr. Byres, just before we move
12	to Item 10.
13	MR. BYRES: Yes.
14	CHAIRMAN SEARLE: Are there any other questions
15	for Mr. Byres on this? Ms. Howard, Ms. Meck Mr. Meck?
16	Seeing no questions.
17	All right. Go ahead.
18	MR. BYRES: Thank you very much.
19	So we've got three projects that we're looking at
20	presenting today. All three of those actually came in under.
21	To date, we have a total what has gone into contingency, a
22	little over \$78.7 million. So we're actually doing fairly well
23	for the year. At least we're in the green, not in the red.
24	So next slide.
25	This is just a recap for per month as we went

1	through the year. So we're we actually got back on track
2	with our estimating and have actually I think we're getting
3	closer and closer to contract pricing as we've gone through the
4	year.
5	So next slide.
6	So for approval, Item 10A, this is a pavement
7	rehab project on US-191. We had three bidders on this project.
8	The low bid was \$583,777. The State's estimate was \$1,031,945,
9	a difference of \$448,168, or 43.4 percent under the engineer's
10	estimate.
11	The biggest changes that we saw was the low
12	bidder indicated he had received a quote for the asphaltic
13	concrete that was very competitive, much less than what the
14	engineer's estimate was. He also has a much higher production
15	rate than what was estimated. We went through and analyzed that
16	bid. After analyzing the low bid, the bid appears to be
17	responsive and responsible, and we recommend award to Sunland
18	Asphalt & Construction, LLC.
19	CHAIRMAN SEARLE: Any questions on this
20	particular project? I would entertain a motion then.
21	MR. MAXWELL: So moved.
22	CHAIRMAN SEARLE: This is to award Item 10A to
23	Sunland Asphalt & Construction as presented. So a motion by
24	Mr. Maxwell. Do I have a second?
25	MR. ELTERS: Second.

1	CHAIRMAN SEARLE: Second by Mr. Elters.
2	If there is is there anyone opposed to the
3	motion? Hearing no opposition.
4	All those in favor say aye.
5	BOARD MEMBERS: Aye.
6	CHAIRMAN SEARLE: Chair votes aye. Item 10A is
7	approved unanimously.
8	MR. BYRES: The next item is 10B. This is a
9	conversion of lighting from high pressure sodium to LED lighting
10	on SR-202 from 24th Street to Scottsdale Road. The we had
11	two bidders on this project. The low bid was \$537,640. The
12	State's estimate was \$800,380, a difference of \$262,740, or 32.8
13	percent less than the engineer's estimate.
14	Upon speaking with the low bidder, the contractor
15	indicated that the cost of the high mass light fixtures was less
16	than the engineer's estimate. He also had a much higher
17	production rate for the replacement of the fixtures than what
18	was estimated by the engineer. Upon analysis of the low bid, it
19	was determined to be a responsive and responsible bid, and we
20	recommend award to Michiana Contracting, Inc.
21	CHAIRMAN SEARLE: Okay. Any questions on this
22	particular question?
23	VICE CHAIR DANIELS: Quick question.
24	CHAIRMAN SEARLE: Ms
25	VICE CHAIR DANIELS: Has the City of Tempe been

1	involved in this conversations?
2	MR. BYRES: Has who?
3	VICE CHAIR DANIELS: The City of Tempe.
4	MR. BYRES: On this one, I cannot tell you.
5	VICE CHAIR DANIELS: I'm not going to hold up
6	anything, but I would just ask that we if we haven't already,
7	and I would assume that we have, but communicate with them.
8	They've got so much development activity along this corridor,
9	and the Tempe Town Lake is such a huge economic driver for them,
10	this will obviously affect that in some way, so I would like to
11	just make sure that they are communicated with and have that
12	discussion about the lighting, the brightness. They've tried to
13	do a lot with their own lighting within their municipality, and
14	I just think it might be a nice courtesy.
15	MR. BYRES: We will certainly make sure that
16	they're invited to the preconstruction conference so that
17	they're
18	VICE CHAIR DANIELS: They may not want to come.
19	I may be inserting myself.
20	MR. BYRES: But we'll make sure the invite goes
21	out.
22	VICE CHAIR DANIELS: Thank you.
23	CHAIRMAN SEARLE: All right. Thank you,
24	Ms. Daniels.
25	Any other questions?

1	All right. I have a do I have I don't have
2	a motion.
3	VICE CHAIR DANIELS: So moved.
4	CHAIRMAN SEARLE: I have a motion by Ms. Daniels.
5	Thank you. And a second?
6	MR. ELTERS: Second.
7	CHAIRMAN SEARLE: Mr. Elters.
8	All right. Is there any other questions or
9	comments? Hearing none.
10	Any opposition to the motion in front of us?
11	Hearing no opposition.
12	All those in favor say aye.
13	BOARD MEMBERS: Aye.
14	CHAIRMAN SEARLE: Chair votes aye. Item
15	passes 10B passes unanimously.
16	Move to 10C.
17	MR. BYRES: Item 10C is a roadway reconstruction.
18	This is Woolford Road from Whipple to SR-260. For this project,
19	we had four bidders. The low bid was \$1,699,500. The State's
20	estimate was \$2,130,949, a difference of \$431,449, or 20.2
21	percent less than the engineer's estimate.
22	After review of the low bid, it was determined
23	that the contractor will purchase the asphaltic concrete from a
24	supplier in Snowflake. We originally have that coming from I
25	forget from much further away than Snowflake. The price is

1	much lower. The engineer's estimate on the milling was to be
2	completed by a subcontractor. The low bidder will actually be
3	doing it with his own workforce at a higher production rate.
4	With the analysis done for the low bid, it was determined to be
5	a responsive and responsible bid, and we recommend award to
6	Sunland Asphalt & Construction.
7	CHAIRMAN SEARLE: And you know, I know we have
8	several people from Show Low here, but you know, concerned
9	that we may not approve this, but considering the cost savings,
10	it would be hard not to.
11	So any other questions for Mr. Byres on this
12	particular contract?
13	All right. I would entertain a motion.
14	MR. ELTERS: So moved, Mr. Chair.
15	CHAIRMAN SEARLE: I have a motion by Mr. Elters.
16	VICE CHAIR DANIELS: Second.
17	CHAIRMAN SEARLE: Second by Ms. Daniels.
18	Is there any other discussion or questions so we
19	can let the people from Show Low go home? All right. Hearing
20	none.
21	All those is there any opposed to the motion
22	in front of us? Hearing no opposition.
23	All those in favor say aye.
24	BOARD MEMBERS: Aye.
25	CHAIRMAN SEARLE: Chair votes aye. Item 10C for

Г

1	Show Low passes unanimously. You're welcome.
2	So with that we'll now move to 10D.
3	MR. BYRES: So Item 10D is a little bit
4	different. This is actually SR-88. On SR-88 we are using a
5	alternative delivery method for construction of the project.
6	We're actually doing a construction manager at risk project, and
7	with that, there has to be a guaranteed maximum price. And so
8	what you're approving today is actually that guaranteed maximum
9	price. So the guaranteed maximum price was \$1,947,155. The
10	engineer's estimate was \$1,898,000. The difference is \$49,155,
11	or 2.6 percent over the engineer's estimate.
12	After analyzing the entire guaranteed maximum
13	price, the analysis states it has been determined that it to
14	be a reasonable and responsible guaranteed maximum price, and we
15	recommend final contract award to Nesbitt Contracting Company,
16	Inc.
17	CHAIRMAN SEARLE: And just for clarification,
18	with a maximum, that there is the good chance that it will
19	come in under that.
20	MR. BYRES: That's the maximum that it could be
21	without any change orders.
22	CHAIRMAN SEARLE: Okay.
23	MR. BYRES: (Inaudible) CMAR gets written so that
24	change orders have to be very explicit. So yes, that will be
25	the maximum that it will ever go.

1	CHAIRMAN SEARLE: But there's still the there
2	is the possibility that they will come in less.
3	MR. BYRES: This is actually done a little bit
4	differently, and we kind of flipped the way we normally do a
5	CMAR. What we've basically done is we took and laid out all of
6	the bid items, and what we'll do is we'll actually run those bid
7	items out until we complete the work or max out that particular
8	line item. So we'll probably take it all the way up to that
9	guaranteed maximum price and do as much work as we possibly can.
10	CHAIRMAN SEARLE: So it's going to be it's not
11	on the funding. It's going to be on the amount of work done?
12	MR. BYRES: Right.
13	CHAIRMAN SEARLE: Very good. Okay.
14	MR. MAXWELL: I have a follow-up question.
15	So obviously you're going to I understand that
16	part of it, but what will this project do to open up SR-88, or
17	is this on a section of SR-88 that's already open?
18	MR. BYRES: No. This will actually open. What
19	this this is the bulk of the work that needs to be done to be
20	able to clear the rock fall that has occurred on the roadway
21	itself. So it will clear that out, be able to take and do all
22	the safety work that's necessary along that stretch, basically
23	even out the roadway coming through. I'm not going to say
24	smooth the road, but even out the roadway coming through that
25	section to be able to make it passable for four-wheel drive and

1	ATVs coming through that section. There's a lot of the work
2	that has actually already been done by ADOT forces for the
3	remainder of the project.
4	MR. MAXWELL: And so if I understand it, like you
5	said, you're going to you've got a project list that you know
6	you're going to get as many of them done as possible, but there
7	is potential that they could hit that maximum, and we're not
8	quite there yet?
9	MR. BYRES: Nope. We will. We will we will
10	have it, because the way it's the way those items are put
11	together, we will be able to clear the road. We'll be able to
12	do everything, but what will probably the ones that we may
13	not be able to get done is, you know, as much clearing, because
14	we're going to take this out as far as we possibly can. So
15	we'll clear the section that's that has to be cleared and
16	taken care of, and then if we still have funding left over,
17	we'll take and kind of work that a little bit further out.
18	MR. MAXWELL: Okay. Thank you, Mr. Byres. Thank
19	you, Mr. Chair.
20	CHAIRMAN SEARLE: All right. Ms. Howard, this is
21	your district. Do you have any questions?
22	MS. HOWARD: No. I'm good. Thank you.
23	CHAIRMAN SEARLE: All right. (Inaudible.)
24	VICE CHAIR DANIELS: No other questions, but this
25	is the major segment that Supervisor Serdy and some of the

1	community stakeholders have really been focused on. So this is
2	the piece that they have all been sort of, quote, waiting for, I
3	think.
4	MR. BYRES: Yeah. And that's why we brought this
5	to the Board
6	VICE CHAIR DANIELS: Yeah.
7	MR. BYRES: and our (inaudible).
8	VICE CHAIR DANIELS: Thank you.
9	CHAIRMAN SEARLE: Okay. If there are no other
10	questions, I would entertain a motion to approve Item 10D as
11	presented.
12	VICE CHAIR DANIELS: So moved.
13	CHAIRMAN SEARLE: Motion by Ms. Daniels. A
14	second by?
15	MR. ELTERS: Second.
16	CHAIRMAN SEARLE: Mr. Elters, I really appreciate
17	your seconding today. It's helped.
18	So I have a motion by Ms. Daniels and a second by
19	Mr. Elters. Any other discussion or questions before I call for
20	the vote? Hearing none.
21	Is there any opposition to the motion? Hearing
22	no opposition.
23	All those in favor say aye.
24	BOARD MEMBERS: Aye.
25	CHAIRMAN SEARLE: Chair votes aye. Item

1	passes Item 10D passes unanimously.
2	MR. BYRES: Thank you.
3	CHAIRMAN SEARLE: Item Number 11.
4	MR. ROEHRICH: So Mr. Chairman, I do have one
5	clarification. I've been asked to clarify one things. When we
6	were addressing when the Board was addressing Item 8, you had
7	called for the motion, which Mr. Meck had given. A second was
8	given by Ms. Daniels. You asked for any opposition. There was
9	none. You called for the vote. You said yes, but then
10	questions started happening, and you did not declare that it
11	passed unanimously.
12	CHAIRMAN SEARLE: Okay.
13	MR. ROEHRICH: So to clarify it, Item 8 passed
14	unanimously; is that correct?
15	CHAIRMAN SEARLE: Yes. This Item 8 passes
16	unanimously. I was, you know, thanking Mr. Maxwell for keeping
17	us on the agenda. It was fortunately, it was a SMART
18	grant questions where I could not close them saying but
19	anyhow, yes, Item 8 passes unanimously.
20	MR. ROEHRICH: Thank you, Mr. Chairman.
21	CHAIRMAN SEARLE: All right. Item Number 9
22	no. Item Number 11, which is suggestions for future board items
23	or agenda items. Is there anything that would like to be
24	brought forward at this time?
25	MR. ROEHRICH: Just a reminder, next meeting is

1	August 16th.	We will meet at the county chambers in Safford.
2		CHAIRMAN SEARLE: Very good.
3		Seeing none, I'm going to go ahead and adjourn
4	the meeting.	Thank you for everybody's participation.

# STATE ENGINEER'S REPORT December 2024

The Status of Projects Under Construction report for December 2024 shows 94 projects under construction valued at \$2,942,856,476.97. The transportation board awarded 5 projects during December valued at approximately \$19.9 million.

During December, the Department finalized 2 projects valued at \$8,355,013.26. Projects where the final cost exceeded the contractors bid amount by more than 5% are detailed in your board package.

Fiscal Year to date we have finalized 47 projects. The total cost of these 47 projects has exceeded the contractors bid amount by 5.1%. Deducting incentive/bonus payments, revisions, omissions and additional work paid for by others, fiscal year to date reduces this percentage to 4.0%.
