Financial Review and Budget

Discussion

The Medical Student Loan Fund (MSLF) is used for operational expenses for accounting services provided by the Arizona Department of Administration Central Services Bureau and for payments on defaulted loans collected by the Office of the Attorney General.

The Board of Medical Student Loans was granted \$4 million in General Fund appropriations to make loans to medical students who are committed to practicing Primary Care. After issuing ten (10) Primary Care loans to Arizona medical students for Academic Year 2023-2024, the balance of these appropriations is currently \$3,161,093.

The Board of Medical Student Loans was granted \$2 million in Medical Marijuana appropriations to make loans to medical students who are committed to practicing Psychiatry. After issuing three (3) Psychiatry loans to Arizona medical students for Academic Year 2023-2024, the balance of these appropriations is currently \$1,796,198.

Timeline, Review and Approval of the Renewal Application, New Application, Forms and Process for the 2024-2025 Arizona Medical Student Loan Program

Discussion/Action

Thirteen continuing medical students are expected to reapply for the Arizona Medical Student Loan Program for 2024-2025. The Board has available funds appropriated by the State of Arizona to fund these returning students and consider new applicants in Primary Care and Psychiatry.

Renewal applications will be distributed on July 26th and due August 12th. The Board will meet in late August to review the thirteen (13) renewal applications for approval. The first disbursements of the 2024-2025 Academic Year funding will be processed in September, with subsequent equal disbursements for winter, spring and summer according to the academic schedule of each school.

New applications will be distributed upon request beginning July 26th. Applications will be accepted through Renewal applications will be due August 12th.

Participant Updates and Requests

Corrine Livingstone, a second-year student in 2023-2024 writes to the Board concerning a necessary change in her academic plan which has resulted in her placement in the Class of 2027. She requests to be considered for continued funding through graduation.

Review of Administrative Options

Discussion/Action

Historically, the University of Arizona College of Medicine-Tucson (UACOM-Tucson) provided the administration of the Board of Medical Student Loans with reimbursement from the private schools of medicine per A.R.S. §15-1723 (H) which states, "Private schools of medicine shall reimburse the university of Arizona for any administrative costs related to processing loans for students at private schools of medicine pursuant to subsection A of this section."

The Board is discussing a change by which the Board of Medical Student Loans would reimburse UACOM-Tucson for all administrative costs to administer the Arizona Medical Student Loan Program from its fund (separate from appropriations to fund loans to students). This will require a change to the legislation. The Board awaits a proposal from UACOM-Tucson.
