The executive session is not open to the public.



March 19, 2021 Anesthesia & Sedation Committee Meeting Agenda

The Anesthesia & Sedation Committee's ("Committee") Chairperson reserves the right to change the order of items on the agenda, except for public hearings set for a specific time.

During the Committee meeting and upon a vote of the majority of a quorum, the Committee may go into executive session to obtain legal advice from the Board's attorney(s) pursuant to Arizona Revised Statute ("A.R.S.") § 38-431.03(A)(3) on any agenda items listed on the agenda. All meeting attendees whose presence is not required in an executive session will be required to leave the meeting room during executive session. Any and all legal action will take place in open session.

II. **CALL TO THE PUBLIC**

Pursuant to A.R.S. § 38-431.01(H), the Committee may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. However, members of the Committee are not allowed to discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action. The Committee, however, may ask staff to review a matter or may ask that a matter be put on a future agenda.

CURRENT STATUTE(S) AND/OR RULE(S) REGARDING ANESTHESIA & V. SEDATION STATUTE AND RULES

Committee to review and discuss current statutes and rules regarding anesthesia & sedation and may make recommendations to the Board regarding whether statutory or rule change(s) should be pursued.

VI. BENEFITS OF A TEAM MODEL, A TWO-PROVIDER MODEL OR A SINGLE PROVIDER MODEL WHEN ADMINISTERING ANESTHESIA/SEDATION

Committee to review, discuss and take possible action to recommend that the Board amend its statutes/rules regarding the most appropriate model(s) to use based on level(s) of anesthesia/sedation administered to patients.

VII. LEGISLATIVE UPDATE – SB1372

Committee to review and discuss SB1372 and its progress, the stakeholders meeting with members of the Arizona House and Senate and may take action to recommend that the Board continue to oppose the Bill.
