Pursuant to Arizona Revised Statute (“A.R.S”) § 38-431.02, notice is hereby given to the members of the Arizona State Board of Podiatry Examiners (“Board”) and to the general public that the Board will hold a meeting open to the public on **Wednesday, November 9, 2022, at 8:30 a.m.** The meeting will be held in Boardroom C located at 1740 West Adams Street, Phoenix, Arizona 85007. The meeting is open to the public. The executive session is not open to the public.
