The Committee reserves the right to change the order of items on the agenda, except for matters set for a specific time. The formal interviews are scheduled to be heard during specific time blocks. However, the Chairman of the Committee reserves the right to call cases in random order. Please note that the recommendations listed on the agenda are merely suggested Committee actions.
