
- 1) **Amend Commission Order 4 (Elk) to reflect a change in the over-the-counter, nonpermit-tag seasons in Units 3A and 4B. Presenter: Josh Avey, Terrestrial Wildlife Branch Chief.** The Commission will consider and may vote to amend Commission Order 4 (elk) for the 2023 season to revise over-the-counter, nonpermit-tag general elk seasons presented to and approved by the Commission on December 2, 2022. Proposed revisions include: 1) a boundary expansion of the Dry Lake Hunt Area in Unit 4B; 2) creation of a new over-the-counter, nonpermit-tag for the Zeniff Hunt Area, in Unit 3A.
- 2) **Executive Session (The Commission will not vote to take on any action during Executive Session).**
  - a) **Litigation and Legal Advice.** The Commission may vote to meet in executive session in accordance with A.R.S. § 38-431.03(A)(3) and (4) for the purpose of discussing and consulting with legal counsel for legal advice in order to consider its position and to instruct legal counsel regarding the Commission's position concerning litigation over the Tonto NF Travel Management Plan.
